NOTIFICATION

The Governor of Tripura is pleased to modify the existing provision of paras 4.2, 5.1, 5.2, 17.3, of the Notification No.F.12 (1) – FIN (G) / 90 dated 8<sup>th</sup> January, 1991 regarding Tripura State Government Employees Group Insurance Scheme – 1983 as follows and to enhance the monthly subscription and Insurance coverage for all the 4 (four) Groups of State Government Employees w.e.f. 1<sup>st</sup> March, 2009.

Existing Provision (modified on 8 <sup>th</sup> January 1991)	Modifies Provision (w.e.f. 1 <sup>st</sup> March, 2009)
<p>4.2 Those employees who were member of the 'scheme' on 31.03.1990 will have an option to opt out of the scheme with subscription unit of Rs.15/- per month. This option should be exercised by 31<sup>st</sup> January 1991.</p> <p>Those employees who do not opt out of the scheme with subscription unit of Rs.15/- per month by that date will be deemed to have opted for the scheme with the subscription of Rs.15/- per month effective from 1<sup>st</sup> March, 1991.</p> <p>The option once exercised (or not exercised) will be treated as final and no further choice will be available.</p> <p>Other employees who opted out of the scheme with the subscription unit of Rs.15/- per month will continue to subscribe for the scheme in unit of Rs.10/- per month till they cease to be in employment with the State Government on account of retirement, resignation, death etc.</p>	<p>4.2 Those employees who were member of the 'scheme' as on 28.02.2009 will have an option to opt out of the scheme with subscription unit of Rs.75/- per month. This option should be exercised by 30<sup>th</sup> May, 2009. The employees who will retire from Government Service on or before 30<sup>th</sup> June 2009 will not be included in the modified provision.</p> <p>Those employees who do not opt out of the scheme with subscription unit of Rs.75/- per month by that date will be deemed to have opted for the scheme with the subscription of Rs.75/- per month effective from 1<sup>st</sup> March, 2009.</p> <p>The option once exercised (or not exercised) will be treated as final and no further choice will be available.</p> <p>Other employees who opted out of the modified scheme with the subscription unit of Rs.75/- per month will not come under the modified scheme and their membership deemed to be ceased. Total accumulation of Savings fund with existing rate of interest will be refunded accordingly.</p> <p style="text-align: right;"><u>Contd.P/2</u></p>

<p><b>5.1</b> The subscription for the scheme will be in unit of Rs.15/- per month. A Group – D employee will subscribe for 1 (one) unit a Group – C for 2 units, a Group – B for 4 units and a Group – An employee for 6 units. Thus, the rate of subscription for a member of the scheme shall be Rs.15/-, Rs.30/-, Rs.60/- and Rs.90/- per month for Group – D, C, B and A respectively.</p>	<p><b>5.1</b> The subscription for the modified scheme will be in unit of Rs.75/- per month. A Group D employee will subscribe for 1 (one) unit, a Group C for 2 units, a Group B for 3 units and a Group A employee for 5 units. Thus, the rate of subscription for a member of the scheme shall be Rs.75/-, Rs.150/-, Rs.225/- and Rs.375/- per month for Group – D, C, B and A respectively.</p>
<p><b>5.2</b> The amount of insurance cover will be Rs.15000/- for each unit of subscription.</p> <p>In other words, the insurance cover for each Group- D, C, B and A employees will be Rs.15000/-, Rs.30000/, Rs.60000/- and Rs.90000/- respectively.</p>	<p><b>5.2</b> The amount of insurance cover will be Rs.75000/- per each unit of subscription.</p> <p>Thus, the insurance coverage for each Group- D, C, B and a employees will be Rs.75000/-, Rs.150000/, Rs.225000/- and Rs.375000/- respectively.</p>



MEMORANDUM

Consequent upon revision of Pay scales (Pay band) of State Government Employees and in supersession of all Memos regarding classification of Groups under Tripura State Government Employees Group Insurance Schemes 1983 it is for information of all concerned that the following classification of employees as Group – A, Group – B, Group – C and Group – D would effect from 1<sup>st</sup> March 2009.

- A** The Government employees holding all posts in the pay band No.4 and HAG + Scale with grade pay ranging from Rs.3700 – 6500/- and Apex scale.
- B** The Government employees holding all posts in the pay band No.3 with grade pay ranging from Rs.2600 – 3500/-.
- C** The Government employees holding all posts in the pay band No. 2 with grade pay ranging from Rs.1600 – 2400/-.
- D** The Government employees holding all posts in the pay band No.1 with grade pay ranging from Rs.1200 – 1500/-.

The rates of subscription for the members of the scheme will be Rs.375/-, Rs.225/-, Rs.150/- and Rs.75/- for Group – A, Group – B, Group – C and Group – D employees respectively.
