NOTIFICATION

In pursuance of Rule, 30 of the Tripura Civil Services Rules, 1967, the Governor, in consultation with the Tripura Public Service Commission is pleased to appoint Shri Sanjit Debbarma TCS Gr-II, SDM, Jampuijala, Sepahijala District to the post of TCS Gr-I (Selection Grade) on ad-hoc basis as a onetime measure in the pay level-19 of the Tripura State Pay Matrix, 2018 with retrospective effect i.e. from the date on which his junior namely Shri Manik Lal Das(SC) was promoted to the post of TCS Gr-I (Selection Grade) i.e. 3rd July, 2021, subject to final outcome of SLP (C)No.19765-19767 of 2015 pending in the Hon'ble Supreme Court of India:-

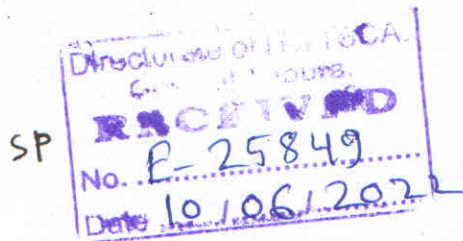
2. Seniority of Shri Sanjit Debbarma shall be placed below Shri Rakesh Debbarma (ST) and above of Shri Manik Lal Das (SC).
3. Their pay etc. shall be fixed as per normal rules.
4. Shri Sanjit Debbarma, TCS shall continue to hold the post presently held by him until further orders.
5. The appointment on ad-hoc promotion as one time measure shall be on the following conditions:-
 - i. Appointment on Promotion are allowed purely on ad-hoc basis subject to final outcome of the SLP pending before the Hon'ble Supreme Court of India.
 - ii. No inter-se seniority is determined /published in respect of these ad-hoc promotions.
 - iii. The ad-hoc appointment on promotion shall not be treated as regular appointment on promotion.
