
NOTIFICATION

Whereas, in exercise of the powers conferred under Section 3 of the Armed Forces (Special Powers) Act, 1958 (28 of 1958) the State Government, vide Notification No. 22(2)/PD/2002(P.I) dated 08.03.2013, had declared 34 Police Stations as disturbed in full and 6 Police Stations as disturbed in part.

Whereas the matter was reviewed and after consideration of the overall law and order situation of the state, in exercise of the powers conferred by Section 3 of the Armed Forces (Special Powers) Act, 1958 (28 of 1958), the Governor is pleased to declare the Police Stations shown in **Schedule-I as disturbed in full (whole area)** and Police Stations shown in **Schedule-II as disturbed only in part**, i.e., in respect of Revenue Villages as indicated in Col. No. 3, with effect from the 5th June 2013.

This is in supersession of the Notification issued vide No. 22(2)/PD/2002(P.I) dated 08.03.2013.
