Notification

For smooth implementation and wide coverage of benefits to working journalists in the state, the Governor of Tripura is pleased to make the following amendments in the "Tripura Media Representatives Accreditation Guidelines, 2020"

Short title and commencement:

- (i) These may be called the "Tripura Media Representatives Accreditation (Amendment) Guidelines, 2022."
- (ii) They shall come into force on and from the date of their publication in the Tripura Gazette.

1. Amendment of Clause 13:

The contents of the clause 13 shall be substituted with the followings-

- "(a) for successfully implementation of the guidelines, the Committee shall time to time recommend the State government for inclusion and exclusion of any clause in the existing "Tripura Media Representatives Accreditation Guidelines, 2020."
- (b) The Committee can independently recommend the State government to withhold any accreditation card of any media representative if he/she violates the norms of Journalistic conduct; those are not described in these guidelines but included in Press Council of India guidelines.
- (c)The committee shall recommend for allocation of accreditation card among media representatives working in the state.
- (d)The committee shall recommend the name of unlisted category of newspaper /electronic media/web media for issuance of accreditation card."

2. Amendment of Clause 14:

After sub-clause 4 of Clause 14, the following sub-clauses shall be inserted namely-

- "(5) Accreditation of representatives of only those media organization will be considered which have been functioning or operating for at least two year (continuously) in the State.
- (6) Accreditation shall be granted only to those media representatives who reside at Tripura or its periphery."

3. Amendment of Clause 16:

After sub-clause (4) of Clause 16, the following sub-clauses shall be inserted namely-

- "(5) Recommendation letter from Editor/Authorized signatory of newspaper, magazine, news agency, television channel, radio organization or news portal for grant of accreditation (not applicable for freelancer category) is mandatory for fresh/re-newel of accreditation card.
- (6) The cases approved for accreditation by the Accreditation Committee shall be sent for police verification and the card shall be issued only after satisfactory report from the Police authorities and the concurrence of the Home Department of the state government."

4. Amendment of Clause 23:

Proviso to Clause 23, shall be substituted with the followings:-

"Provided that in case of Distinguished Journalists & Veteran, the media accreditation card shall remain valid for a period of 5(five) years from the date of issue and may, subject to the other provisions of these Guidelines, be renewed for a period not exceeding 5(five)years at a time on the expiry of the existing validity period."

5. Amendment of Clause 24:

After sub-clause (3) of clause 24, the following sub-clauses will be inserted namely-

"(4) If any accredited media representative changes media house in mid of profession then he/she shall be liable to inform the Director ICA immediately about the present house(employer) and submit a fresh application by his/her existing employer for renewal of accreditation card cancelling the previous accreditation card.

(5) The accredited media representatives shall surrender the existing card to the Director, Information & Cultural Affairs Department within seven (7) days from the date of relieving from previous organization."

6. Amendment of 'FIRST SCHEDULE':

The 'FIRST SCHEDULE' of the "Tripura Media Representatives Accreditation Guidelines, 2020" shall be substituted with the followings:-
