**NOTIFICATION**

**WHEREAS**, The Superintendent of Police (Traffic), Tripura vide letter No. 8543-48/F.NECP-2024/SP(T)/RSV/2024 dated-13/12/2024 has communicated a special arrangement for restriction of movement of vehicles with identification of emergency/alternative routes and parking areas in connection with 72<sup>nd</sup> North East Council Plenary to be held at Agartala **from 20/12/2024 to 22/12/2024**.

**AND**

**WHEREAS**, I, Dr. Vishal Kumar, IAS, District Magistrate, West Tripura District am satisfied that it is necessary to impose restriction on the movement of vehicles at the time of the visit of the Hon'ble Union Home Minister of India and other dignitaries in connection with 72<sup>nd</sup> North East Council Plenary to be held at Agartala **from 20/12/2024 to 22/12/2024** and it is also necessary to maintain smooth movements of vehicular and pedestrians.

**NOW, THEREFORE**, in exercise of power conferred upon me under Rule 105 of the Tripura Motor Vehicle Rules, 1991 read with Section 116 and 117 of Motor Vehicle Act, 1988, I do hereby specify the following :

On 20/12/2024 from 0700 hrs. to 2200 hrs. the roads from Agartala MBB Airport to Hotel Polo Towers has been restricted for plying of various types of vehicles. In order to ensure smooth traffic management, the commuters to use/follow the following alternatives routes:

**Alternative/Emergency Routes:**

1. Narayanpur – Narsingarh – Ramnagar - Gandhigram Bazar – Salbagan – Rubber Board – Chanmari.
2. G.B – Indranagar – Dhaleswar - Math Chowmuhani – Jogendranagar – Bye pass.
3. A.D Nagar – Battala – Fire Service – Ker Chowmuhani – Sankar Chowmuhai- Barjala – Maila Khola via Bharat Ratna Club to MBB Airport.
4. G.B – ILS – SDO Chowmuhani – Nandannagar – Banikya Chowmuhani – Khayerpur.

72<sup>nd</sup> North East Council Plenary will be held on 21/12/2024 at Pragna Bhawan followed by the state dinner at Tripura State Museum, Ujjayanta Palace. In order to maintain traffic order, restriction of movements of vehicles and pedestrians will be imposed on the following roads:

- (a) Goalabasti towards Hotel Polo Towers.
- (b) From Mutriprangan towards Hotel polo Towers.
- (c) Old Raj Bhavan back side towards Mutriprangan.
- (d) Heritage Park towards Mritika Crossing.
- (e) Barjala towards Bolagiri Crossing.
- (f) Lichubagan Crossing towards Goalabasti.
- (g) Haradhan Sangha towards North Gate.
- (h) Bhagaban Thakur Chowmuhani towards Bodhjung Chowmuhani.
- (i) Lal Bahadur Chowmuhani towards Power House Crossing.

- (j) Ganaraj Chowmuhani towards Womens College.
- (k) Jackson Gate towards Lions Gate.
- (l) Orient Chowmuhani to R.S. Bhawan.
- (m) B.K. Chowmuhani towards R.S. Bhawan.
