- 3. The last date of submission of Tender along with all relevant documents is on\_10/10/2018 at 17:30 hrs and it will be opened in the presence of the bidder or their authorized representative (having valid authorization letter) who may like to be present. In case the day happens to be a holiday, the Tender will be received and opened on the next working day within the specified time.
- **4.** The Tender without EMD will automatically be rejected.
- **5.** The undersigned reserves the right to accept/reject any or all the Tender Notice (s) or part thereof without assigning any reason.

### 6. Eligibility Criteria :-

- a. Vehicles with Commercial registration will only be allowed to participate in the tender, failure to provide registration details will result in the rejection of tender.
- b. If, any bidder offer for only Private vehicle, it will not be considered and the tender will be rejected.

### 7. Terms & Conditions:-

- a. The bidders may quote for one/two vehicle but they should clearly & separately quote rates for each vehicle for which these are offered.
- b. The MarutiWagon R (CNG)&MarutiEeco (CNG) should be of white/standard colour and in good running conditions and not have been purchased before 2015.

- c. Xerox copy of Commercial Registration Document/Smart Card, GST TIN registration of owner, Tax token, Insurance, Pollution under Control Certificate of the vehicle along with PAN Card of the Owner, etc. are to be submitted along with the Tender.
- d. Kilometre reading meter should have been fitted in the vehicle in good running condition.
- e. A driver having valid driving license should be placed with the vehicle and all expenditures of the driver should be borne by the owner.
- f. Basic accessories, fuel, lubricants, dusters and the proper maintenance of the vehicle should be the responsibility of the owner.
- g. If the vehicle is having facility of running on both Petrol & CNG mode, the vehicle should run first on CNG mode up to a distance of 120 KM per day as per requirement of concerned official using the vehicle. If the vehicle is required to run beyond 120 KM on that day, it should be refuelled with CNG again.
- h. The vehicle should be normally used from 9:30 AM to 6:00 PM during working days, but in case of requirement, the vehicle may be used beyond normal duty hours even during holidays for which no extra payment except the normal detention & running charges will be given.
- i. The vehicles would be used for journey to any place within the State of Tripura.
- j. No additional claim except, the detention & running charges will be accepted for day to day journey, out station journey and halt (s).
- k. Any breakdown, accident, defects etc. will have to be attended and to be repaired by the owner at his own cost and risk. Alternative arrangement of similar quality vehicle is to be made by the owner within one hour in case the vehicle becomes unfit for journey, failing which; similar category of vehicle will be hired by the officials whose payment will be realized from the bill of the owner.
- Log book in prescribed format is to be maintained by the owner and day to day journeys etc. are to be entered with the signature of the controlling officer.
- m. Bill in triplicate in favour of the State Project Director, RUSA, Under Education (Higher) Department, Agartala along with the logbook is to be submitted to the undersigned for release of payment on monthly basis.
- Taxes etc. as admissible will be deducted from the bill at sources.
   TDS certificate will be issued on submission of requisition.

- If the condition of the vehicle and service of the driver are not found satisfactory, the vehicle will be discontinued at any time and EMD will be forfeited.
- p. In normal case, the vehicle may be discontinued by giving 1 (one) month notice from the office of the undersigned.
- q. The rate scheduled has been prescribed at <u>clause no.8</u>. The bidder may quote rate for Running Charge per Km as CNG.
