NOTICE INVITING TENDER FOR SUPPLY OF HDPE FENCING NET MATERIAL FOR MGNREGA SCHEME UNDER HEZAMARA AGRI. SUB-DIVISION DURING 2018-19

Tender in sealed cover superscribed as "Tender for supply of fencing net material for MGNREGA scheme under Hezamara Agri. Sub-Division for the year 2018-19" are invited for and on behalf of the Governor of Tripura from reliable resourceful and Agency/Distributor/Supplier/Lamps/Co-Operative having financial stability for supply of the fencing net material (Polymer)-HDPE (High Density Polyethylene), size of bundle-50 meter length and 1.5 meter width which equals to 75 sq. meter per bundle for implementation of MGNREGA schemes during the year 2018-19.

The tenderer should quote the rates both in figures and words in the prescribed format, which is available in the office of the undersigned on any working day during the office hours upto 48 hrs before the scheduled time of dropping of the tender.

The sealed tender will be received in tender box kept in the office of the undersigned upto 3:00 PM on 15/06/2018 & will be opened on the same day at 3:30 PM, if possible in the office of the undersigned in presence of the tenderers or his/her authorized representatives.

TERMS AND CONDITIONS

- 1. Rates should be quoted per unit of bundle both in figures and words for supply to delivery point of the commodity indicated in the tender notice inclusive of expenses for loading/unloading etc.
- 2. There should be no over writing on the tender. Conditional tender whom amounts to the deviation of the terms & conditions contained in the tender notice will not be entertained.
- 3. The tenderers are required to submit his/her earlier supply order copy (photocopy) of the same fencing material as an experience proof.
- 4. The rate will remain valid for the financial year 2018-19 if approved by the Government and may be extended or curtailed if necessary.
- No extra transport cost will be provided for carrying of the fencing material under any circumstances.
- 6. The value of quantity found short at delivery point including value of containers, if any will be recovered from the supplier at rate which may be fixed by the Director of Agriculture, Govt. of Tripura, Agartala & such quantities will be treated as not carried & same quantities of the material should be supplied again.
- All precautionary measures should be taken at the cost of contractor so that the fencing material
 may not damaged in any way during loading, unloading & transit and any rat damaged fencing
 material will not be accepted at any cost.
- 8. In case no staff is available at delivery point to receive the inputs, it should be informed to the undersigned or In-Charge HQ Store, Hezamara immediately for making alternative arrangement to receive it, but in no case the inputs should be returned back to supply point.
- 9. Each Tender should accompany with Earnest Money @ 1% of the estimated cost i.e Rs. 5,000/-(Rupees Five thousand) only in the shape of "Deposit at Call" from any Nationalized/Govt. undertaking Bank pledged in favour of the undersigned, up to date Income Tax Clearance Certificate, Professional Tax Clearance Certificate, GST registration etc. and attested copy of

- Nationality Certificate should also be enclosed alongwith the tender, failing which no tender will be entertained.
 - 10. The tenderer must have his/her readily valid Vendor registration certificate for online payment as per MGNREGA norms and submit a photocopy alongwith the tender form.
 - 11. The EMD will be kept as security money with the undersigned for the successful tenderer and rest will be returned to the unsuccessful tenderer after the rate approval and acceptance by the higher authority and the earnest money shall be forfeited to the Govt. if the successful tenderer fails to supply the required materials in time.
 - 12. The Earnest money of the unsuccessful tenderers shall be refunded after the approval and acceptance of rate by the approving authority.
 - 13. The Earnest money of the successful tenderer (s) shall be treated as part of security money and the earnest money shall be forfeited to the Govt. if the successful tenderer fails to comply with the terms and conditions of tender during the period.
 - 14. In case the security deposit and any other money due to the contractor from the Government does not suffice to meet up such expenditure, the Government will have the right to recover the amount of such expenditure from the contractor by other suitable means.
 - 15. The undersigned reserves the right to accept or reject the tender fully or partly including the lowest one without assigning any reason & also reserves the right to distribute the works to more than one agency/supplier, if considered necessary.
 - 16. In case of any disputes, the decision of the Director of Horticulture & Soil Conservation, Government of Tripura shall be final & binding on the contractor.
