Notice Inviting Quotation

Sealed quotations are hereby invited from supplier for 3 (three) no of 1.5 ton air conditioner under Tripura Rural Livelihood Mission (TRLM). Quotations may be dropped in the tender box kept in the office of the Chief Executive Officer, TRLM, Bholagiri, Agartala till 27/04/2022 upto 3.00 PM and to be opened on the same day, if possible. The Specification of the said air conditioner is enclosed at **annexure-I** to mention the specification of the AC by the bidders. Format for bid submission is given at **annexure-II**

Terms and condition are given below:

1. An earnest money (EMD) amounting to ₹ 10,000/- (Ten Thousand only) in the form of Deposit at call or Draft drawn in favour of "Tripura Rural Livelihood Mission Society" payable at Agartala from any Nationalized bank/ Tripura Gramin Bank/Tripura State Cooperative Bank shall be submitted along with the sealed quotation. The said earnest money will be converted to security money for successful bidders who would be offered the work and will be refunded only after successful execution of the work. For others earnest money shall be refunded.
2. The bidder should have valid trade licence, GST, PAN card. Copy of the said documents should be enclosed with the quotation.
3. Bidder in whose favour the supply order will be issued will have to complete the supply & installation of the 1.5 ton air conditioner within 7 days of receiving of supply order. In case of failure of supply of above said 1.5 ton air conditioner within the specified period, the supply order shall be liable for cancellation or may forfeit the EMD partially or fully.
4. Rate should be quoted both in digits and words.
5. Applicable tax shall be recovered from the bill.
6. Rate should be inclusive all taxes and charges as applicable.
7. The undersign reserves the right to accept or reject any quotation including the lowest one without assigning any reason therefore.
8. All disputes shall lie within the jurisdiction of Agartala only.
