: To apply to the Child Development Project Officer (CDPO) of the concerned AMC / Nagar Panchayat / R.D. Block in prescribed application form, which shall be available from the office of the Child Development Project Officer (CDPO), free of cost.

: The Child Development Project Officer (CDPO) will sunction the pension with prior approval of the Director of Social Welfare and Social Education.

- a. Attested Copy of certificate indicating that 'the applicant belongs to APL household, issued by the C.E.O. of the AMC, E.O of the Nagar Panchayat or B.D.O of the respective R.D. Block Attested Copy of EPIC of the applicant.
- b. Attested Copy of EPIC of the applicant.
- c. A certificate issued by the Medical Board on the percentage of physical challenge may be submitted and certified by competent authority of the Department (CDPO), Chairman, Panchayat Samity, Pradhan of G.P/AMC/TTAADC on complete scrutiny.
- d. Attested copy of an Age Proof certificate issued by AMC / Nagar Panchayat / Gram Panchayat / Village Committee of TTAADC areas.

: Coverage by this Scheme will be terminated automatically in case o death of beneficiary. However pension for the month in which the beneficiary dies will be paid to his nominee / legal heir.
