# ADVERTISEMENT FOR ENGAGEMENT OF LEGAL ADVISOR ON CONTRACTUAL BASIS IN REVENUE DEPARTMENT

Applications are invited from eligible candidates for the post of Legal Advisor in Revenue Department on contractual basis.

#### Number of posts:-

01(one) post of Legal Advisor for Revenue Department.

#### **Remuneration & Benefits:-**

Fixed Rs.1.00 lakh per month. No other allowances are admissible. In addition to government holidays, maximum 15 days of leave without deduction of pay will be given.

### Eligibility criteria:-

- (i) Applicant must be a Law graduate from any recognized university.
- (ii) Applicant must have minimum 20 years of experience in conducting civil and revenue cases in any court of competent jurisdiction.
- (iii) Retired Law Officer in any Central or State Government Department, or a retired Judicial Officer worked as TJS Gr-I under Government of Tripura or similar rank in Government of India.
- . (iv) Any Law Officer, who had worked in Law Department in Government of India or States not below the rank of Deputy Secretary or TJS Gr-I would get preferential treatment, if found otherwise suitable.
  - (v) Preference may also be given who have publication in Revenue Laws.

#### Period:-

The contract shall be for a period of 6(six) months on experimental basis.

#### **Conditions:-**

- (i) The appointment to the post of Legal Advisor in Revenue Department shall be purely on a contractual basis.
- (ii) The appointment will be made on a full time basis, and the appointee will have no right of private practice during the period of contract.
- (iii) The appointee shall be bound by oath not to take up after end/termination of contract of any case on which he has worked during the period of contract.
- (iv) The Appointing Authority has the right to terminate the contract at any time without giving any reason. No legal proceedings shall be drawn against the Revenue Department or the Appointing Authority for termination of the contract.

#### Nature of job:-

- (i) Conducting legal analysis of all Revenue Department cases and researching legal matters.
- (ii) Dealing of cases like land acquisition, adverse possession of land and safeguarding the interest of State Government and for saving tax payers' money etc.
- (iii) Providing advice on all revenue legal matters.
- (iv) Drafting legal opinions and memoranda and briefing documents.
- (v) Reviewing legal LA cases, adverse possession cases etc.
- (vi) Advice on a variety of legal issues and legal interpretation of various Court Orders.
- (vii) Reviewing of all existing Revenue Act & Rules and its amendment etc.
- (viii) Dealing with complex matters with multiple stakeholders.
- (ix) Drafting & editing of para wise comments/draft affidavit, etc.
- (x) All the issues as may crop up time to time for which legal opinion is necessary.

He will directly report to Additional Secretary, Revenue.
