**NOTIFICATION**

**Subject:- Appointment of State Chief Information Commissioner in the Tripura Information Commission.**

Under the Right to Information Act,2005, the Government of Tripura has constituted the Tripura Information Commission, which is located at Agartala. The Powers and functions of the State Chief Information Commissioner in the Tripura Information Commission are as per the RTI Act,2005.

2. It is proposed to appoint the State Chief Information Commissioner in the Tripura Information Commission,
3. The Act provides that the State Chief Information Commissioner –
  - (i) shall be a person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media or administration and governance.
  - (ii) shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition to the appointment of a person as State Chief Information Commissioner.
4. Persons who have attained the age of 65 years shall not be eligible for appointment.
5. The salary, allowances and other terms and conditions of service of the State Chief Information Commissioner shall be as per the “Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019”.
6. Persons fulfilling the criteria and interested for appointment to the post of State Chief Information Commissioner may send their particulars in the **enclosed proforma**, by post, to the Under Secretary, General Administration(AR) Department, New Capital Complex, Secretariat, Agartala, Tripura West, Pin-799010 or through e-mail to [gaar.agt-tr@nic.in](mailto:gaar.agt-tr@nic.in) so as to reach before **05:30 PM on 30<sup>th</sup> June, 2022**. Persons serving under the State/Central Government of any other organization, should send their particulars through proper channel (administrative/Ministry/Department or State-UT/Central Government or the Controlling Office respectively).
