No claim/request for part payment shall be acceptable under any circumstances. In addition the successful quotationer shall also be liable to deposit the GST as applicable on the deal to the Sale Tax authorities. Failure on the part of the quotationers to comply with the above will render his/her earnest money deposit. Earnest money deposit will be refunded to the unsuccessful quotationer on application as soon as the quotation is finalized which shall be retained till such time delivery of the auctioned materials are completed.
