

The last date for receipt of the quotations on 16/11/2020 up-to 4.00 P.M.

All quotations should be accompanied by a bank deposit at call for an amount of **Rs. 3,000/- (Rupees Three thousand) only for each vehicles** on any National Bank having branch at Kailashahar in favour of **the District Magistrate & Collector, Unakoti District**, as earnest money. Quotation without earnest money will not be considered. The Earnest Money of the unsuccessful auctioneers(s) will be returned after completion of tender for auction process but for the successful quotationer it will be returned after completion of contract and no interest will be paid for this period to the successful quotationer.
3. The tender box will be opened on the next working day at 17/11/2020 if possible. Quotationers or their authorized representatives may remain at the time of opening of the quotation.
4. The successful quotationers will have to make full payment of offered price within 07 (Seven) days from the date of receipt of order of acceptance of
