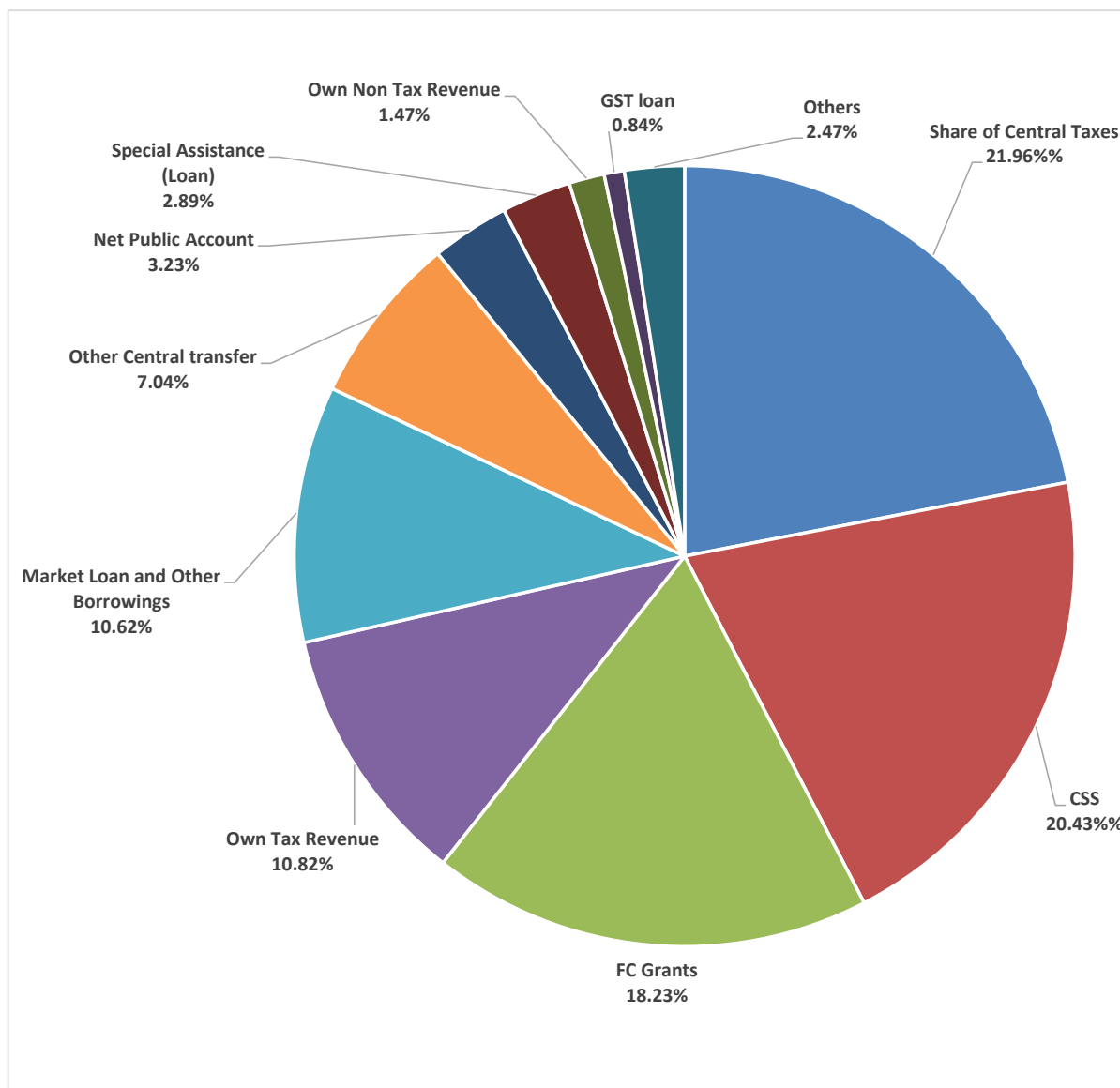

AS PER BROAD ITEMS OF EXPENDITURE

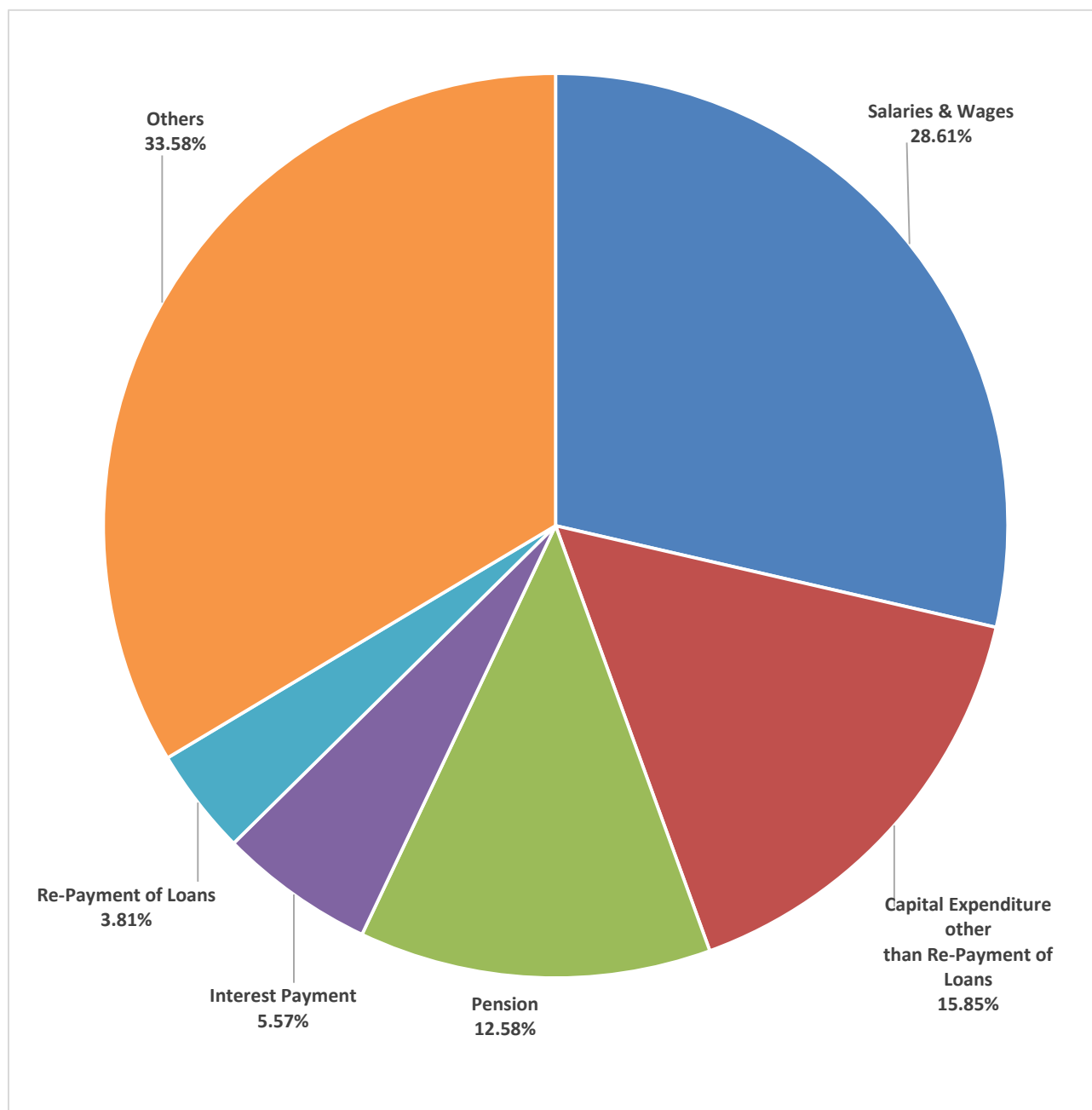
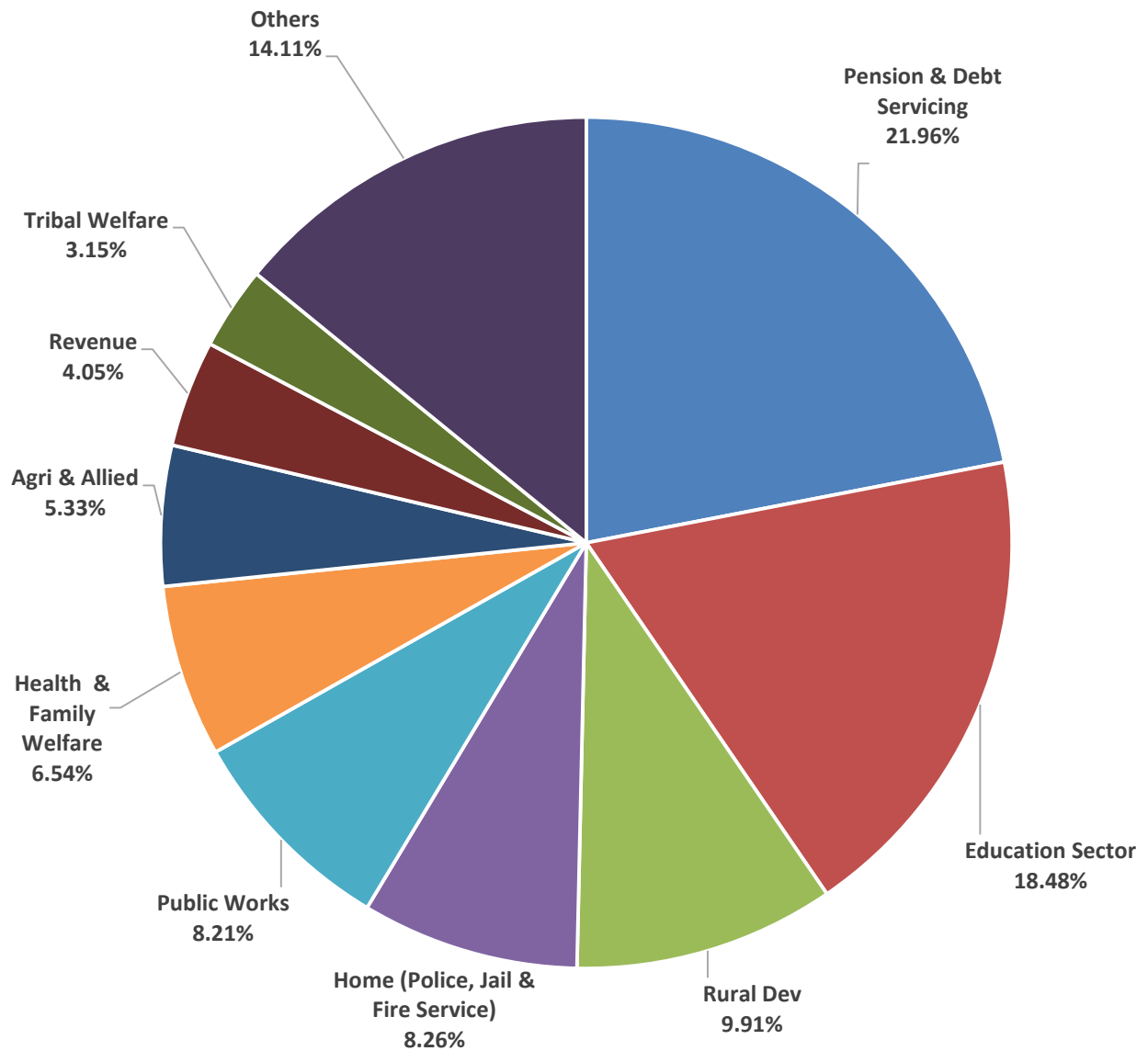


CHART-3

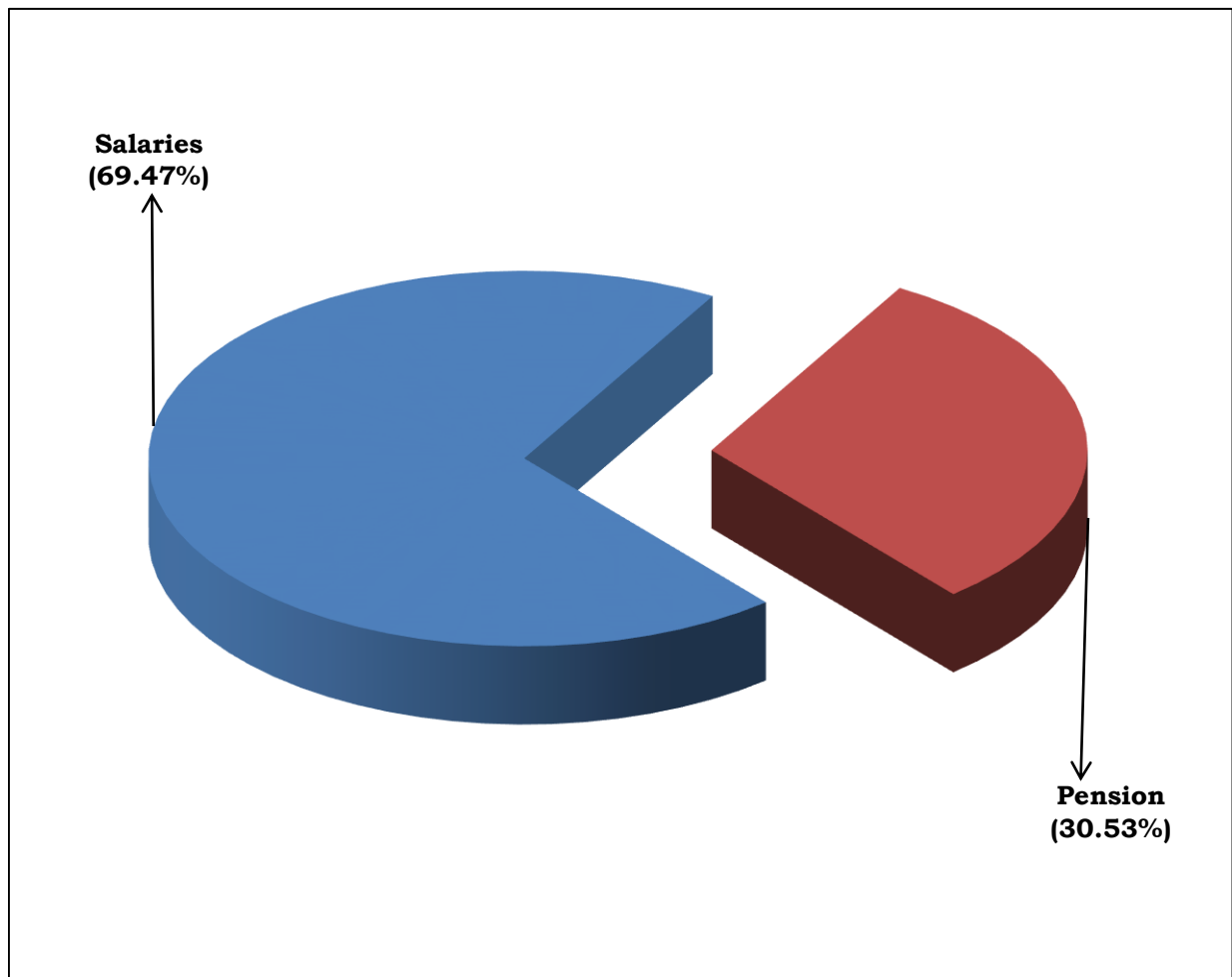
