#### NOTIFICATION

**Subject:** Appointment of State Chief Information Commissioner in the Tripura Information Commission - inviting applications thereof.

In exercise of the powers conferred by Section 15(1) of Right to Information Act, 2005, the Government of Tripura has constituted the Tripura Information Commission.

- 2. As per Section 15(2) of the said Act, the State Information Commission shall consists of
  - a) the State Chief Information Commissioner, and
  - b) such number of State Information Commissioners, not exceeding ten, as may be deemed necessary.
- 3. This is regarding filling-up of the vacant post of the State Chief Information Commissioner in Tripura Information Commission,
- 4. Section 15(5) & 15(6) of the Act provides that the State Chief Information Commissioner
  - a) shall be a person of eminence in public life with wide knowledge and experience in law, science and technology, social service, management, journalism, mass-media, administration and governance.
  - b) shall not be a Member of Parliament or Member of the Legislature of any State or Union Territory, as the case may be, or hold any other office of profit or connected with any political party or carrying on any business or pursuing any profession. It is clarified that cessation/termination of holding of office of profit, pursuing any profession or carrying any business is a condition to the appointment of a person as State Chief Information Commissioner.
- 5. Persons who have attained the age of 65 years shall not be eligible for appointment.
- 6. The salary, allowances and other terms and conditions of service of the State Chief Information Commissioner shall be as per the "Right to Information (Term of Office, Salaries, Allowances and Other Terms and Conditions of Service of Chief Information Commissioner, Information Commissioners in the Central Information Commission, State Chief Information Commissioner and State Information Commissioners in the State Information Commission) Rules, 2019".

7. Persons interested for appointment and fulfilling the criteria to the post of State Chief Information Commissioner may send their particulars in the enclosed proforma by post to the Under Secretary, General Administration (AR) Department, New Capital Complex, Secretariat, Agartala, Tripura West, Pin: 799010 or through e-mail to gaar.agt-tr@nic.in so as to reach before 05:30 PM on 31st July, 2024. Persons serving under the State/Central Government of any other organization should send their particulars through proper channel (Administrative Department/Ministry under State-UT/Central Government or the Controlling Office respectively).
