Corrigendum

i. This is with reference to the Request for Proposal issued by Directorate of Skill Development (DSD), Government of Tripura for submission of proposal for selection of Manpower Recruitment Agency to deploy professionals for DSD vide Ref No. NO.F. 7(50)/DSD/2017/10671 dated 14th February, 2020.

ii. In Clause 2.3 (d) (Eligibility/Qualifying Criteria of the Agency) it was stated that “Agency should have minimum average annual audited turnover of Rs. 20 Crore for last 3 financial years (i.e 2016-17, 2017-18 & 2018-19) for similar assignment (deployment of manpower to public/private sector). Audited balance sheet and profit & loss a/c should be furnished along with proposal.”.

The above mentioned line shall be replaced and may be read as:

“Agency should have minimum average annual audited turnover of Rs. 10 Crore for last 3 financial years (i.e 2016-17, 2017-18 & 2018-19) for similar assignment (deployment of manpower to public/private sector). Audited balance sheet and profit & loss a/c should be furnished along with proposal”.

iii. In Clause 2.1(b) the date for submission of RFP is mentioned till 10th March, 2020 which has been extended till 16th March, 2020. Accordingly, the other related dates and points may be read as below:

Date for opening of Technical Bid	11:00 A.M, 17 th March, 2020
Notifying the selected bidders in Technical Bid	19 th March, 2020
Date for opening of Financial Bid	20 th March, 2020
Non Refundable Tender Cost	Rupees 5,000 through Demand Draft from any Nationalized Bank, drawn in favour of DDO, Directorate of Skill Development payable at Agartala as Non-Refundable Processing Fee
Earnest Money Deposit (EMD)	Rupees 1,00,000 through Demand Draft from any Nationalized Bank, drawn in favour of DDO, Directorate of Skill Development payable at Agartala as Non-Refundable Processing Fee

- iv. In Clause 2.1(j) it is stated that “ The Earnest money deposit (EMD) to an amount of Rs. 50,000 only shall be furnished in the form of demand draft/ Bank Guarantee drawn on any Nationalized Bank in favour of Director, Skill Development payable at Agartala.” The above mentioned line shall be replaced and may be read as:

“The Earnest money deposit (EMD) to an amount of Rs. 1,00,000 (Rupees One Lakh) only shall be furnished in the form of demand draft/ Bank Guarantee drawn on any Nationalized Bank in favour of DDO, Directorate of Skill Development payable at Agartala.”

- v. The other contents, terms and conditions of the RFP Document is remain unchanged.
