CORRIGENDUM

Ref:- NIT No.F.II-8(1)-EX/2020(P-1)/03-06 dated 02.01.2021 and Corrigendum No.F.II-8(1)-EX/2020(P-1)/129-32 dated 19.01.2021 published by the Commissioner of Excise, Government of Tripura in the e-procurement portal <https://tripuratenders.gov.in>

As per approval of the decision taken in the pre-bid meeting held on 11.01.2021, the following changes are made in connection with the aforesaid tender :-

- A. Point 1.2.2(a) (ii) :- Bidder should be a profit making organization and should have minimum turnover of Rs.4.00 Crore from either Polyester based tamper evident security hologram or Information Technology (IT)/ Integrated Excise Management System (IEMS) during last three financial years (2017-18, 2018-19 and 2019-20). Copies of audited balance sheet along with a Chartered Accountant's Certificate in support of this claim must be submitted.
- B. Point 1.2.2 (a) (iii) :- Bidder must be a Company registered under the Indian Companies Act, 1956 or 2013 and must be a manufacturer of Polyester based tamper evident security hologram or IT / IEMS having their registered offices with legal presence in India and shall be in business for atleast three years on the date of submission of bid. The sole bidder or bidding consortium shall have a minimum three years' experience in manufacture and supply of High Security Holograms including Master Origination Lab and QR code based Integrated Excise Management System. In this case, Certificate of Incorporation / Registration under companies Act, 1956 or 2013 or LLP Act of 2008 and client certificate to be submitted.
- C. Point 1.2.2 (a) (iv) :- The sole bidder or bidding consortium must possess in his premises all relevant and capable machines specified as compulsory in point 6, 7 & 8 of **Annexure- I** of this tender document. All the machines must be installed within the premises of the bidder and under a secured environment. The successful bidder shall not be allowed to subcontract or sublet any work or part thereof to any outside agency. Bidder shall have to submit an affidavit on Non-Judicial Stamp paper stating that all compulsory facilities, equipment (Plant & Machinery) and processes shall be carried out, in- house and none will be subcontracted or sublet to any outside agency.

D. Point 1.2.2(a)(ix) :- The sole bidder or bidding consortium must have experience of manufacturing and supplying Polyester based tamper evident security hologram and QR code based Integrated Excise Management System to at least one State Excise Department for atleast one year in last three financial years (2017-18, 2018-19 and 2019-20). Copies of all required documents like Purchase order, machines etc. to be submitted to prove experience.

E. Point 2.19 :- PERT CHART FOR PRODUCTION

The successful Bidder shall start the supply of High Security Hologram from the manufacturing unit, as per the design approved by the Commissioner Excise, Government of Tripura **within 4(four) weeks** from the date of placement of initial purchase order after approval of Art Work failing which the contract will be cancelled by the Commissioner and the successful Bidder shall be liable for compensating the loss incurred by the Department for making alternative arrangements for getting the supply of excise labels. The Bidder shall complete the implementation of Hologram with QR Code based IEMS **within 12(twelve) weeks from date of Award of Contract** and the same will be inclusive of the period of readiness of all hardware and connectivity components at the supply chain. In case of any extension due to delay for aforesaid purpose, consideration of the circumstance by the Commissioner of Excise shall be final in this purpose.

F. The sole bidder or bidding consortium has to submit the details as given in **Annexure- VI** alongwith the Technical Bid.

All other specifications, terms and conditions etc. of the aforesaid DNIT may remain unchanged.
