- a) Please read in line No. 2 of Clause No. 4.1 of the RFP document, as "Institution/ Company/ Consulting Firm/ Society/ Entrepreneur / Proprietor" in place of "Institution/ Company/Consulting Firm/ Society/Entrepreneur" The other part of the clause shall remain unchanged.
- b) The minimum Service Charge for Manpower supply is **3.85%** (Three point Eight five percent) of total salary per person per month. Quoted rate should not be below 3.85%. In case of quoting of similar rates by two or more bidders, the bidder securing higher/ highest technical score as per the provisions of Clause No.6.10 of the RFP document shall be considered as successful bidder as 1st Parameter to finalize the bid. If required, as 2nd Parameter, the turnover of bidders, who will be exercised in 1st Parameter, shall be considered to finalize the bid.
- c) Please read 1st and 2nd line of Clause No.8.1 of the RFP document, as "The payment of Manpower supply shall be made to the agency on monthly basis. The Agency shall raise the bill in duplicate within the 1st week of succeeding month" in place of "The payment of Manpower supply shall be made to the agency on quarterly basis (in every three months). The Agency shall raise the bill in duplicate within the 1st week of succeeding month of each quarter". The agency should raise bill with relevant supporting documents only after making payment to the engaged Manpower within due time. The other part of the clause shall remain unchanged.
- d) Clause no. 8.4 of the RFP document is reconstituted as "No advance payment shall be made to the successful bidder." The remaining part of the Clause is deleted.
