

MEMORANDUM

Subject: Release of further installment of Dearness Allowance.

The undersigned is directed to refer to the subject mentioned above and to state that the Governor of Tripura is pleased to decide grant of further installment of Dearness Allowance @5% over the Basic Pay with effect from 1<sup>st</sup> January, 2024 to the State Government employees. With the release of this installment, total quantum of Dearness Allowance payable to the State Government employees with effect from 01-01-2024 shall stand at 25% (20% + 5%) over the Basic Pay.

2. The term 'basic pay' in the revised pay structure means the pay drawn in the prescribed Level in the Pay Matrix as per Tripura State Civil Services (Revised Pay) Rules, 2017 read with its 1<sup>st</sup> Amendment, 2018 as accepted by the State Government, but does not include any other type of pay like Special Pay, Personal Pay, NPA, Honorarium and any other addition to pay.
3. The Dearness Allowance will continue to be a distinct element of remuneration and will not be treated as pay within the ambit of FR 9(21).
4. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
5. The above rate of Dearness Allowance would also be admissible for the employees of T.P.S.C., T.B.S.E., Grant-in-Aid Schools and Urban Local Bodies.
6. Subject to availability/ generation of resources, other PSUs and Autonomous Bodies may take decision for providing aforesaid installment of Dearness Allowance to its employees w.e.f. 01-01-2024.
7. The arrear amount of salary due to increase of Dearness Allowance has to be paid within 31<sup>st</sup> March, 2024 after necessary deduction for income tax etc. The arrear amount of salary is required to be made in manual bill format.

2. The monthly remuneration of Fixed Pay employees (who have been engaged against fixed pay posts created by keeping regular scale post in abeyance) will be enhanced by further 5% over the existing fixed monthly remuneration w.e.f. **01.01.2024**. With the release of this installment, total quantum of monthly remuneration of fixed pay employee shall stand at 25% (20% + 5%) with effect from **01.01.2024**. Grant of this additional monthly remuneration shall not be taken into account for determination of minimum basis pay of the aforesaid category of fixed pay employees, at the time of their respective regularization. This rate shall, however, not be applicable to employees on consolidated monthly fixed pay.

3. The arrears of aforesaid enhanced remuneration/wages for the month of January and February, 2024 has to be paid within 31<sup>st</sup> March, 2024. The arrears of enhanced remuneration/wages is required to be made in manual bill format.

**Subject: Release of further installation of Dearness Relief.**

The undersigned is directed to refer to the subject mentioned above and to state that the Governor of Tripura is pleased to decide grant of further instalment of Dearness Relief @ 5% over the basic pension/ basic family pension as admissible under Tripura State Civil Services (Revised Pension) Rules, 2017 read with its 1<sup>st</sup> Amendment, 2018, with effect from 01-01-2024 to the State Government pensioners and family pensioners. With the release of this instalment, total quantum of Dearness Relief payable to the State government pensioners and family pensioners with effect from 01-01-2024 shall stand at 25 % (20 % + 5 %) over the basic pension/ family pension, as the case may be.

2. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded off to the next higher rupee and the fractions of less than 50 paise may be ignored.
3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/ family pension to the State Government Pensioners / Family Pensioners are authorized to calculate and disburse Dearness Relief at the above rate and manner in each individual case from 01-01-2024.
4. The expenditure on payment of Dearness Relief on pension/ family pension to the State Government Pensioners / Family Pensioners respectively shall be debitable to the Major Head '**2071-Pension and other Retirement Benefits**'.
