#### MEMORANDUM

Subject:- Release of further installment of Dearness Allowance.

The undersigned is directed to refer to this Department's Memorandum of even number dated 30 July 2014 on the subject captioned above and to state that the Governor of Tripura is pleased to decide grant of further instalment of Dearness Allowance @ 5% over the revised pay (Band Pay + Grade Pay) with effect from 1st January, 2015 to the State Government employees. With release of this instalment, total quantum of Dearness Allowance payable to the State Government employees with effect from 01-01-2015 shall stand as 69% (64% + 5%) over the revised Basic Pay.

- 2. Total admissible amount of Dearness Allowance shall be worked out in whole rupee. Fraction of a rupee below 50 paise should be ignored. Fraction of a rupee, 50 paise and above shall be rounded off to the next higher rupee.
- 3. The above rate of Dearness Allowance would also be admissible for the employees of High Court of Tripura, TPSC, TBSE, Grant-in-Aid Schools, ULBs, TTAADC, PSUs and 7 non-commercial Autonomous Organizations viz. (i) Tripura State Social Welfare Board, (ii) Tripura State Pollution Control Board, (iii) TREDA, (iv) State Council for Science & Technology, (v) Tripura Board of Wakf, (vi) Tripura State Cooperative Union and (vii) SIPARD.
- 4. Subject to availability/ generation of resources, PSUs and other Autonomous Bodies may take decision for providing aforesaid instalment of Dearness Allowances w.e.f. 01-01-2015

Subject: - Release of further installment of Dearness Relief.

The undersigned is directed to refer to this Department's Memorandum of even number dated 30 July 2014 on the subject captioned above and to state that the Governor of Tripura is pleased to decide grant of further instalment of Dearness Relief @ 5% over the revised pension with effect from 1st January, 2015 to the State Government Pensioners and Family Pensioners. With this release of instalment, total quantum of Dearness Relief payable to the State Government Pensioners & Family Pensioners with effect from 01-01-2015 shall stand as 69% (64% + 5%) over the revised pension.

- 2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 3. The Pension Disbursing Authorities including Public Sector Banks handling disbursement of pension/family pension to the State Government pensioners and family pensioners are authorized to calculate and disburse Dearness Relief at the above rates and manner from 01-01-2015.
- 4. The expenditure on payment of Dearness Relief on pension/family pension to the State Government Pensioners and Family Pensioners is debit able to the Major Head `2071-Pension and other Retirement Benefits'


