The Bid Fee should be paid electronically over the Online Payment facility as indicated against each work in accordance to the tender value, is **Non-Refundable** and to be deposited to the Govt. account automatically as revenue. The Bidders' EMD amount shall be refunded to the bidder, after the "**Award of Contract (AoC)**" event is completed in the Tripura e-Procurement Portal, and only on receipt of "**Performance Bank Guarantee**" from the **L1** Bidder in Physical Form. 
