NOTIFICATION

Sub: -Minimum Qualification for Appointment of Teachers and other Academic Staff in

Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education.

The proviso prescribed under clause 6.3 in the University Grants Commission (Minimum Qualification for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (3rd amendment) Regulations, 2023 has been substituted by UGC notification No.F.9-1/2010(PS/MISC) Pt.Vol.II dated 06th June, 2024, (4th Amendment) Regulations, 2024(UIN:2/2024) with the following:

*"The criteria for promotions under Career Advancement Scheme laid down under these Regulations shall be effective from the date of notification of these Regulations. However, to avoid hardship to those faculty members who have already qualified or likely to qualify till **31st December, 2024** as per the UGC Regulations on Minimum Qualification for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education, 2010 a choice may be given to them either for being considered for promotions under the 2010 or 2018 Regulations. The date of eligibility shall be retained as the date of promotion. On the date of submission of the application, the candidate should fulfill all eligibility criteria required for promotion."*

2. The Govt. of Tripura has adopted the revision of pay scales of teachers and equivalent academic staff vide notification dated 27th December, 2019 subject to various provisions of the scheme of revision of pay scales as contained in the Regulations, 2018 issued by UGC and amendments thereof from time to time in this behalf. Henceforth, after careful consideration of the aforesaid amendment notification, the Govt. of Tripura has decided to favor the same as for the Teachers and other Academic Staff in Universities and Colleges under the Education (Higher) Department, Tripura.

3. The earlier Notification vide No.F.1(499)-DHE/ESTT(G)/2017 Dated 31-01.2024 stands repealed.
