



**Trams & Conditions**

1. The rate should be quoted for detention per day and per KM as per format given at Annexure-A.
2. The valid document i.e, Road Tex, Road Permit (Commercial) Registration, Insurance, Pollution Certificate, Commercial License etc. should be submitted along with the tender as per Motor Vehicles Act.
3. Amount should be written both in the figures and words.
4. Providing fuel, Lubricants, Towel, Dusters, and maintenance etc. for the cars will be responsibility of the supplier.
5. The vehicle should be placed within 03(three) days from the date of issue of final order.
6. The supplier will provide minimum accessories for the car.
7. The driver should be given prescribed liveries by the supplier.
8. In case of need, the driver has to be changed within 24 hours of being informed and if the car is not available on any day no payment (detention charge) would be made for the day and also for the next day.
9. In case of repair, a similar car shall have to be provided by the supplier as replacement during repair.
