EMPLOYMENT NOTIFICATION

Applications in plain paper are hereby invited from bonifide Indian citizen having following eligibility for the appointment to the post of One Veterinary Assistant for a period of one year purely on temporary basis for veterinary care of 4 wildlife species nurtured under the Conservation Breeding programme at Sepahijala Zoological Park on fixed emoluments of ₹ 9,000/- (Rupees nine thousand) only per month. The selected candidate shall however have no claim whatsoever for regular/ permanent job in Sepahijala Zoo or elsewhere in the Department.

Willing candidate fulfilling the terms & conditions mentioned below may submit the application (by post or in person) in his/her own handwriting affixing in it a recent passport size colour photograph so as to reach the office of Director, Sepahijala Zoological Park, P.O:- Bishalgarh, District:- Sepahijala 799102, Tripura on or before **30th September, 2015**. A screening committee shall examine the applications which shall take interview to evaluate suitability of a candidate for the job. The date, time and place of interview will be intimated to the applicants by post and in the website of the Forest Department www.tripuraforestdepartment. No TA/DA would be paid to appear for the interview.

The eligibility conditions are given below:

1. Age limit below 65 years.
2. Submission of Medical certificate: The candidate must be of good health for undertaking strenuous outdoor duties. Medical fitness certificate issued by Government doctor shall have to be annexed with the application
3. Qualification:

Essential: Madhyamik Passed with completion of One year training in Veterinary Science which is minimum.

Desirable: Retired person of ARD Department trained in Veterinary Science with ability to communicate effectively both in verbal and in written form, enthusiastic and has natural inclination towards owning and leading public programme including health management of wildlife species shall be considered suitable for the job. He/She should be able to maintain records in regard to health care and management of 4 species of Conservation Breeding Programme.

Applications received after **30th September, 2015** shall be treated as invalid.

4. Job Profile:

(i) The place of posting & duty of veterinary assistant is at Sepahijala Zoological Park. And depending on necessity the selected candidate may have to move to / sent to other forest areas in the State.

(ii) The selected candidate shall be responsible to monitor health and management of 4 species in Conservation Breeding Centre at Sepahijala Zoo under the guidance of VAS of Sepahijala Zoo.


(iii) The selected candidate shall have to maintain veterinary record on daily basis for the 4 species being nurtured in Conservation Breeding programme.

iv. He/ She may be assigned other similar job in this Zoological Park.

5. A copy of detailed bio-data and attested photo copies of all the original documents in support of age, educational/ technical & additional qualification (if any) Indian Nationality, experience, PRC ST/ SC/ OBC certificate etc should be attached with application.

6. Engagement may be terminated after issuance of prior notice if performance of the selected candidate is found by the Director of Sepahijala Zoo to be poor or below average during the course of duty.
