<u>Terms of Reference for Appointing of a Chartered Accountant</u> <u>Firm for Conducting Audit of Accounts of Tripura CAMPA</u>

SCOPE OF WORK:-

1. Detailed activities of the services mentioned in Scope of Work are as follows:-

- a) Reconciliation of all Treasury/ Bank Accounts.
- b) Ensure all financial transactions are recorded in Cash Book and reflected in Tresury accounts/ Pass Book and any deviation is to be reported to the authority immediately.
