

Sl No	Category	Revised rate of festival grant
1.	Group-C/ Group-D employees/ Employees recruited on fixed pay basis by keeping in abeyance the regular scale posts / Pensioners/ Family Pensioners/ Home Guard/ SPOs / Anganwadi Workers/ Anganwadi Helpers and other similar workers engaged with prior concurrence of the Finance Department.	Rs.700/- (Rupees Seven hundred) only per head.
2.	DRWs/ MRWs/ PTW/ Fixed Pay Employee and other similar workers engaged with prior concurrence of the Finance Department.	
3.	DRWs/ MRWs/ Home Guard/ PTW/ Fixed Pay Employee and other similar workers engaged prior to 01/04/2004 without concurrence of the Finance Department.	

2. All other terms and conditions for sanction of festival grant contained in the aforesaid memo shall remain unchanged.
