Notice Inviting Quotation

Sealed quotations are hereby invited from supplier of 1 (one) 25 KVA Diesel generator under Tripura Rural Livelihood Mission (TRLM). Quotations will be received in the SMMU on 26/04/2021 upto 3.00 PM in the office of the Chief Executive Officer, TRLM, Bholagiri, Agartala and to be opened on the same day, if possible. The Specification of the said 25 KVA Diesel Generator is enclosed at **annexure-I**. Format for bid submission is given at **annexure-II**.

Terms and condition are given below:

- 1. An earnest money (EMD) amounting to ₹ 10,000/- (Rupees Ten Thousand only) in the form of Deposit at call or Draft drawn in favour of "Tripura Rural Livelihood Mission Society" payable at Agartala from any Nationalized bank/ Tripura Gramin Bank/Tripura State Cooperative Bank shall be submitted along with the sealed quotation. The said earnest money will be converted to security money for successful bidders who would be offered the work and will be refunded only after successful execution of the work. For others earnest money shall be refunded.
- 2. The bidder should have valid trade licence, GST, PAN card, IT return for last 3 (three) years. Self attested copy of the said documents should be enclosed with the quotation.
- 3. Bidder in whose favour the supply order will be issued will have to complete the supply of the 25 KVA Diesel generator within 30 (thirty) days of receiving of supply order. In case of failure of supply of above said 25 KVA Diesel generators within the specified period, the supply order shall be liable for cancellation or may forfeit the EMD partially or fully.
- 4. Product Brochure/Leaflet should be attached (For which rate is quoted).
- 5. In case OEM- Authorized dealership certificate, In case of manufacturer/supplier- proof of establishment of firm/company registration, licence, trade license or any other document issued by appropriate government body/municipal corporation etc.
- 6. Technical Specification compliance as per Annexure-I. Compliance against each specification should be given.
- 7. The rates shall be offered as per the format Annexure II.
- 8. In case the supplied material does not match with the Technical specification as mentioned in Annexure- I, the supply may be rejected with no liability to State Mission Management Unit of TRLM, hence supplier is advised to ensure compliance of Technical specification before Delivery at SMMU, TRLM.
- 9. The 25 KV of Diesel Generator should have manufacturer Guaranty/ Warranty.
- 10. The firm should not submit more than one offer/product.
- 11. The bidders can be present during opening of the bid as invited if they wish to
- 12. TRLM shall not be responsible for any postal delay and offers received beyond stipulated date and time shall not be considered.
- 13. Any extensions, corrigendum, addendum, amendments, clarifications etc. if any to the NIQ document will be posted on TRLM website. Bidders should regularly visit Website to keep themselves updated.

- 14. The evaluation criteria for comparison of rates for the purpose of identifying the lowest bidder shall be based on lowest rate offered without considering GST.
- 15. Payment will be made on receipt of material and submission of bill along with proof of transportation and no advance payment will be given for the said purpose.
- 16. The bidder shall be liable for commissioning and installation of the generator.
- 17. Rate should be quoted both in digits and words.
- 18. Applicable tax shall be recovered from the bill.
- 19. Rate should be inclusive all taxes and charges as applicable.
- 20. The undersign reserve the right to accept or reject any quotation including the lowest one without assigning any reason therefore.
- 21. All disputes lie within the jurisdiction of Agartala only.
