The e-procurement website will not allow any bidder to attempt bidding, after the scheduled date and time. **Submission of bids physically is not permitted.** A Pre-bid meeting will be held at **3.00 Pm of 01/12/2020** in the chamber of the undersigned.

Bid Fee and Earnest Money Deposit are to be paid electronically over the Online Payment facility provided in the Portal, **any time after Bid Submission Start Date & before Bid Submission End Date**, using Net Banking. The Bid Fee of **Rs.1000.00 (Rupees One Thousand)** only, as paid electronically over the Online Payment facility, is **Non-Refundable** and to be deposited to the Govt. account automatically as revenue. The Bidders' EMD amount shall be refunded to the bidder, after the **"Award of Contract (AoC)"** event is completed in the Tripura e-Procurement Portal, and only on receipt of **"Performance Bank Guarantee"** from the **L1** Bidder in Physical Form. Lowest Bidder (**L1**) have to deposit **"Performance Bank Guarantee"** within a date and time, as specified by the tender inviting authority through **letter of Intent(LOI)** to the **L1** Bidder for depositing "Performance Bank Guarantee" in lieu of EMD Refund.
