## NOTIFICATION

In exercise of the powers conferred by clause 26. of the Tripura Telecom Infrastructure RoW Guidelines, 2022 (TTIRoWG, 2022), the State Government hereby makes the following guidelines further to amend the TTIRoWG, 2022, namely: -

- (1) These guidelines may be called the Tripura Telecom Infrastructure RoW (Amendment) Guidelines, 2023.
  (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. In clause 3 of the TTIRoWG, 2022 (herein after referred to as the said guidelines), In the second paragraph, the words ", except for mobile tower" shall be deleted.
- 3. In clause 3 of the said guidelines,

In the third paragraph, the proviso shall be substituted, namely: -

"Provided that in case of establishment of **mobile tower or** pole over a private building or structure, the licensee shall submit an intimation, in writing, to the appropriate authority, prior to commencement of such establishment:"

4. In clause 3 of the said guidelines,

In the fourth paragraph, the proviso shall be substituted, namely: -

"Provided further that along with the intimation, he/she shall also submit the details of the building or structure, where the establishment of **mobile tower or** pole is proposed, and a copy of certification by a State Government authorized structural engineer, attesting to the structural safety of the building or structure, where the **mobile tower or** pole is proposed to be established."

5. In clause 6 of the said guidelines, -

In the first paragraph, "Rs. 5,00,000/- (Rupees Five Lacs)" shall be substituted with "Rs.1,00,000/- (Rupees One Lac)"

6. In clause 6 of the said guidelines, -

In the second paragraph, the proviso shall be substituted, namely:-

In case of existing telecom infrastructure that had been installed on or after 08 September 2017 (date of issue of Order specifying Appropriate Authority), where in formal permission has not been obtained by the concerned licensee, the necessary application for obtaining clearance for all those telegraph infrastructure shall be submitted along with certification as per para 7(2)(x) and (xi) and with administrative fee to the appropriate authority for regularization within one year of issuance of these guidelines.

- In sub-clause (1) of clause 7 and sub-clause (3) of clause 8 and sub-clause (1) of clause 9 of the said guidelines, for the word "<u>https://sugamsanchar.gov.in</u>", the word "<u>https://gatishaktisanchar.gov.in</u>" shall be substituted.
- 8. In clause 7 of the said guidelines, sub-clause (2), serial (b) iv) shall be deleted.

9. In clause 7 of the said guidelines, in sub-clause (2), in serial (x), the proviso shall be substituted, namely: -

"Certification of the technical design by a State Government authorized structural engineer or institute of National and International repute like IITs, NITs or structural engineer registered with any other State Government in India, attesting to the structural safety of the overground telegraph infrastructure";

10. In clause 7 of the said guidelines, in sub-clause (2), in serial (xi), the proviso shall be substituted, namely: -

"Certification, by a State Government authorized structural engineer or institute of National and International repute like IITs, NITs or structural engineer registered with any other State Government in India, attesting to the structural safety of the building, where the tower or other above ground contrivances is proposed to be established on a building";

- 11. In clause 7 of the said guidelines, sub-clause (2), serial (xiii) shall be deleted.
- 12. In clause 7 of the said guidelines, in sub-clause (2), in serial (xvi), the following shall be added after the proviso:

TSPs/IPs may submit general Indemnity Bond also to each Appropriate Authority for all towers or other above ground contrivances erected under his/her jurisdiction, a copy of which may be provided with each application.

- 13. In clause 7 of the said guidelines, in sub-clause (2), in serial (xviii), in the proviso, the words "Acknowledgement receipt issued by LSA (DoT) of the" shall be deleted.
- 14. In clause 7 of the said guidelines, sub-clause (2), serial (xxvii) shall be deleted.
- 15. In clause 8 of the said guidelines, in sub-clause (2), in serial (iii), the proviso shall be substituted, namely: -

"On new pole/ over ground structures **on government land** for Micro Communication Equipment/ Small Cells. The TSP/IP shall submit an appropriate application form (as per clause 7 above) for establishment of new pole/ over ground structures for deployment of Micro Communication Equipment/ Small Cells."

16. In clause 8 of the said guidelines, in sub-clause (3), in serial (ix), the proviso shall be substituted, namely: -

"Copy of certification, by a State Govt. authorized structural engineer or institute of National and International repute like IITs, NITs or structural engineer registered with any other State Government in India, attesting to the structural safety of the building or over ground structure or street furniture, where the Micro Communication Equipment/ Small Cells are proposed to be deployed;"

- 17. In clause 9 of the said guidelines, sub-clause (2), serial (viii) shall be deleted.
- 18. In clause 27 of the said guidelines, sub-clause (8) shall be deleted.
- 19. In clause 27 of the said guidelines, sub-clause (12) shall be deleted.
