- 2. The agency shall ensure quality (star print) of the hoardings & display. The hoardings in the durable iron structure & also shall maintain the hoardings for 6 (six) months, so that during this 6 (six) months period the hoardings are displayed properly on 24\*7 hr. Basis.
- 3. After installation of the hoardings, the cost of printing of hoardings along with 1<sup>st</sup> month mounting charges will be paid after submission of the bills. Thereafter, the payment will be made on monthly proportionate basis and after submission of the bill.
- 4. The organization must have a valid trade licence related to Advertising Agency/Firm.
- 5. The organization shall have submitted the self-attested copies of Agency Registration certificate, PAN card, GST registration certificate.
