**MEMORANDUM**

In reference to the memorandum issued vide F.No.3 (125)-RD (TRLM)/2023/14400-05 dated 08.12.2023, and memorandum issued vide No.F.3(125)-RD(TRLM)/2023/Part-3/3507-10 dated 06.06.2024, the Common Aptitude Test (CAT) for different posts is scheduled to be held on 30.06.2024 at ICFAI University, Kamalghat, Mohanpur, Agartala, Tripura, Pin - 799210. Other important details are given below:

1. At the time of reporting for the CAT, candidates should bring one printed copy of the submitted application form bearing the token number (system generated), 1 copy of latest colour photo ( passport size), one photo ID proof (Aadhar/ Voter ID/ Driving License/ Passport) and black ball point pen. No separate hall ticket/ admit card will be issued.
2. The schedule of Common Aptitude Test (CAT) is given below:

3. Entry will be closed 30 minutes before the scheduled time of examination.
4. Using smart watch/ camera pen/ calculator/ mobile phone/ Bluetooth device/ head phone/ any other electronic gadget are strictly prohibited in the examination hall.
5. Candidates will be shortlisted for GD/ PI on the basis of the result of CAT. List of such candidates shall be available on the websites: [trlm.tripura.gov.in](http://trlm.tripura.gov.in), and [rural.tripura.gov.in](http://rural.tripura.gov.in) and [tripura.gov.in](http://tripura.gov.in).
6. No TA/ DA shall be provided to the candidates for appearing CAT/ GD/ PI.
