**MEMORANDUM**


Subject: - Submission of annual Immovable Property Return (IPR)-reg.

Attention of all Head of Departments/Departments is drawn to this office Memos vide even number dated 29<sup>th</sup> November, 2019 and 5<sup>th</sup> February, 2020 (copy enclosed) in connection with submission of IPRs through online. As per the said circular, the last date of submission of online IPRs was 29<sup>th</sup> February, 2020.

2. It has been observed that, most of the Cadre Service officers under the State Government have not been able to submit their IPRs in prescribed format of Schedule-II through online-mode within the stipulated date i.e. 29<sup>th</sup> February, 2020 on account of failure in opening NIC email ID, seeding of AADHAR number, updating of bio-data in ERS, technical glitches in e-sign signature etc.

3. Keeping in view of the above, it has been decided that, the last date for online submission of IPR for the year 2019 in respect of the Cadre Service officers excluding TCS/TPS/TFS under the State Government is extended **up-to 31<sup>st</sup> March, 2020** and thereafter, no further date for submission of online IPR will be extended.
