

Acknowledging its importance, the Law & Parliamentary Affairs Department, Government of Tripura, plays a key role in ensuring good governance to the people. Amongst other functions allocated to this department under the Government, the department is more importantly engaged in the functions such as tendering legal advice on variety of issues referred to by various departments of Government and also performing consultative role in regard to proposals for legislations, framing of statutory rules, regulations, notifications, byelaws and finalization of important MoUs etc.

This department is entrusted with the administration, supervision and control of Law Officers including Government Advocate, Government Pleaders, Public Prosecutors, Addl. Public Prosecutors and Assistant Public Prosecutors in different courts and in the matter of grant of fees of retainer ship to them and the Standing Counsels, as well as reviewing their fee structure from time to time. The amicus-curie appointed by the various courts are also entitled to receive payments as per rules from this department. This Department is also vested with the responsibility of preparation of panels of advocates for conducting government cases in the High Court, District Courts and in different Tribunals and appointment of advocates out of such panels to defend interest of the departments of the Government.

This Department in the capacity of administrative department of the District and other subordinate Courts is also engaged in the supervision and monitoring of the execution of various plan/non-plan schemes, which includes the construction and repairing of the Court Buildings, Residential Quarters for Judicial Officers and staff and Bar Association Buildings at different places as well as scheme for Family Courts. This department is also mandated with the authority of appointment of Notaries.

Notable achievements of the departments during the Year 2012-2013, are as highlighted in this Report Card.

APPOINTMENT OF NOTARY PUBLIC

Law Department has appointed Notary Public for all revenue sub-divisions, as per Notaries Act, 1952 and Notaries Rules, 1956, making it much easier for the



general people to get their various urgent and necessary documents authenticated at their doorstep and without spending time. The names of the Notaries are published in the Tripura Gazette in the beginning of every calendar

year, according to the provision of Section 6 of the Act. During the reporting period, the department has completed appointment of Notary Public for all the revenue sub-divisions.

APPOINTMENT OF PUBLIC PROSECUTORS 🧢

Appointment of Government Lawyers, for conducting government litigations in all courts is one of the salient functions of the Law Department. The department has appointed Assistant Public Prosecutors for the Executive

Magistrate Courts of all the Revenue Sub-divisions, During the reporting period, the department has appointed such Assistant Public Prosecutors for the Executive Magistrate Courts of all the newly created Revenue Sub-divisions.

🤝 TRIPURA LAW TRAINING INSTITUTE 🧢


The Tripura Law Training Institute (TLTI) has started functioning. For the present, it has been accommodated in the old High

- 3 A new Uniform Resource Locator (for short URL), designed by the NIC, Tripura, has been launched to effectively manage and monitor the government cases pending in different Sub-ordinate courts of the State, Hon'ble High Court of Tripura and Hon'ble Supreme Court of India. All the Government Departments, PSUs have been requested to upload their respective case status in that specially designed URL and responding to that almost all have uploaded the required information.



Law & Parliamentary Affairs Department, being the administrative department of Tripura Legislative Assembly, initiates proposals for summoning and



prorogation of the Assembly Sessions and sends the government businesses to the Assembly. Its function is also extended in drafting, processing and monitoring of all State Laws from the stage of introduction in the Legislative Assembly to the

stage of obtaining assent of the Governor or the President, as the case may be. It maintains the record of all Principal legislation of the State. During the reporting period, following Principal Legislations of the state have been initiated and processed by the department-

- The Tripura Lokayukta (Amendment) Act, 2012,
- The Tripura Appropriation Act, 2013,
- The Tripura Appropriation (No.2) Act, 2013,
- The Tripura Appropriation (No.3) Act, 2013,
- The Tripura Value Added Tax (Second Amendment) Bill, 2012,
- The Tripura Medicare Service Persons and Medicare Service Institutions (Protection of Violence and Damage to Property) Bill, 2013.

PERFORMANCE OF STATE LEGAL SERVICES AUTHORITY

The Law Department is the administrative department of the Tripura State Legal Services Authority (for short "TSLSA"). The TSLSA is a statutory body under a Central Legislation called "Legal Services Authorities Act, 1987". The State Legal Services Authority monitors and guides the District Legal Services Authorities and Sub Divisional

Legal Services Committees in achieving the aims and objectives of the Act. The general public who need any legal help / legal aid may contact the concerned Sub Divisional Legal Services Committee / District Legal Services Authority and the State Legal Services Authority, as the case may be, for their

needs. Since inception the State Legal Services Authority has done yeomen's service to this society and has organized a number of Lok Adalats at Pre-Ligitative Stage and many cases have been settled at Permanent Lok Adalat. Performance of the TSLSA, during the reporting period, is as follows-

With the grants available under Thirteenth Finance Commission towards Improvement of Justice Delivery in the State of Tripura, under the Component 'Morning/Evening/Special Magistrate/Shift/Holiday Courts', Holiday courts are regularly being conducted on every 4th Sunday in the existing courts, in different stations, with approval of the High Court. During this period, total Sixty eight numbers of such Holiday Courts have been organized, wherein 26,259 nos. of cases have been disposed of. Total 18,553 nos. of cases have been successfully disposed of through ADR mechanism. 17 Nos. of judicial officers have been sent for training within and outside state, with the fund available under the component 'Training of Judicial Officers'.



It is obligatory for the State to ensure equality before law and a legal system which promotes justice on a basis of equal opportunity to all. Policing is a part of delivery of justice – pro-activism against injustices. Despite of its several limitations, Law & Parliamentary Affairs Department has been contributing to the best of its ability to achieve that constitutional pledge and towards ushering in a free, transparent and people oriented administration of justice and to convey smooth, complicacy-free, unexpensive and easily accessible alternative justice delivery system.
