## NOTIFICATION

- The Advocate, so appointed, shall submit joining report to the Law Department immediately after joining along with copy of his Pan Card, Aadhaar Card/Number, Bank Account Details such as Account Number, Branch Name, IFS Code.
- This will take immediate effect and will remain in force until further order to 5. be issued in this regard.
