1. Background

Tripura Rural Livelihood Mission (TRLM) Society is implementing the Deendayal Antyodaya Yojana – National Rural Livelihood Mission (DAY-NRLM) for economic and social development of rural women in the State. Presently, more than 3 lakh active rural women members are functional into around 33,000 women Self Help Groups (SHGs).

Further, to make these SHGs more sustainable they have been federated into 14554 Village Level Federations and 41 Cluster Level Federations. These federations are working as mini banks in villages and meeting up different financial need of women SHG members for augmenting their livelihoods and enhance their family income. Apart from these TRLM is providing regular training to these SHGs and handholding these SHGs to improve their quality.

As TRLM is implementing the livelihood mission, so, augmenting existing livelihoods by improving the package of practices, introduction of new livelihoods are the key component of TRLM. Presently, Presently, TRLM is promoting different farm, non-farm and livestock based livelihood activities with Mahila Kisans in rural areas. Presently TRLM is directly intervene with the livelihood activities of around 80,000 women SHG members. The major activities being taken up for livelihoods under different segment is given below.

- Farm based livelihoods: Improved Paddy cultivation, Vegetable Cultivation through Agro Ecological Practices (AEP), Nutrition Garden, floriculture, horticulture, Mushroom cultivation etc.
- Livestock based livelihoods: Goat rearing, Pig rearing, Fishery, Poultry, and Dairy.
- Food processing
- Micro enterprises

For implementation of these activities maintaining the standard package of practices a large number of Community resource persons namely Krishi Sakhi, Pashu Sakhi, Matsya Sakhi etc. are working in field. These CRPs provide trainings, conduct the farmer's field schools, show demonstration to the farmers, and monitor the activities of farmers, planning with farmers as per seasonal calendar.

2. Scope of Work:

- Identification of KPIs as per the package of practices.
 - Development of Android based application to track the livelihood activities of Individual Mahila Kisans.
 - o Tracking of farm land/livestock sty with GPS tagging.
 - o Capturing the details of crop/ livestock rearing.
 - o Tracking of different triggers of the package of practices by the CRPs.
 - o Alert generation for the CRPs, based on the timeline when the activities to be taken up as per the package of practices.
 - Tracking the level of production, consumption, selling and profit of farmers.
 - o Android based report generation, web based report generation.
 - Training of CRPs, who shall use the android application.
 - Development of master trainers.
 - Regular updation and maintenance of the Software.
 - Different modules to be prepared for the farm / livestock/ Non-farm sector within a single system.
 - Dashboard for training materials.
 - Dashboard for higher management.

3. Duration of the Assignment

The android based software shall be developed within 60 days' time. Field trial and implementation to be started within 90 days from the date of inception of awarding of the proposal. Total three modules shall be required namely one for tracking of farm livelihood, one for livestock and one for Micro Enterprises within the single solution. Initially the agreement shall be signed for minimum 5 years for customization and management and maintenance of the software. Once after signing the agreement all the source code in hard copy and soft copy need to be provided to the TRLM by the selected agency.

4. Project Support

TRLM will provide available necessary information, data, reports and other documents required for accomplishing the objective of the assignment. However, the professionals of the agency will have to visit field operations for collection of additional information. TRLM would provide necessary liaison with thematic persons of SMMU, BMMUs and DMM Us to facilitate the work smoothly.
