

**Minutes of the preparatory meeting of "Proti Ghore Sushason 2.0" was held under the chairmanship of District Magistrate & Collector, West Tripura at 11:00 am on 02.11.2023 at the Conference Hall of O/o the District Magistrate and Collector, West Tripura.**

At the outset, District Magistrate & collector, West Tripura welcomed to all in the meeting and initiated discussion on "Proti Ghore Sushason 2.0" under West Tripura District.

1. Launching day programme of "Proti Ghore Sushason 2.0" under West Tripura District will be held on 9<sup>th</sup> November 2023 at 11.30 AM in the Conference Hall of DM Office , West Tripura.
2. Hon'ble Sabhadipati, PRI representatives (Hon'ble Chairperson of Panchayat Samiti & Block Advisory Committee) will be invited to remain present in the launching programme of "Proti Ghore Sushason 2.0" under West Tripura District & also various benefits will be distributed in that day.
3. Location & fixation of dates for Vikash Meetings, Field Level Camps, District Level Melas shall be submitted by SDMs, BDOs on or before 04/11/2023. **(Action by SDMs, BDOs)**
4. During the meeting it was decided that SDMs & BDOs will act as Nodal Officer in Block Level & Sub-Divisional Level respectively for implementation of "Proti Ghore Sushason" under West Tripura District and also SDMs coordinate with all BDOs and line departments under their jurisdiction to make the programme a grand success. **(Action by SDMs, BDOs)**
5. Vikash Meeting: Block, Panchayat, and wards level to be completed within 10<sup>th</sup> to 14<sup>th</sup> Nov' 23. 2 days field level camps to be organized within 15<sup>th</sup> to 30<sup>th</sup> Nov' 2023 & 2 days District Level Mela shall be completed within 1<sup>st</sup> December to 15<sup>th</sup> December 2023. **(Action by SDMs, BDOs)**
6. Public representatives across all levels should be invited to Vikash meetings, Field level camps and District level melas to ensure their participation. **(Action by SDMs, BDOs, ICA)**
7. It has been decided that TRLM, Panchayat Secretary, GRS etc. shall involved for mobilisation of SHGs and beneficiaries for smooth functioning of the programme. **(Action by BDOs)**
8. Preference will be given on Developmental Services as the regulated services may be provided from camps. **(Action by SDMs, BDOs)**
9. Target for distribution of benefits under various scheme (both central & state) and services shall be fixed by SDMs & BDOs as per the prescribed format enclosed herewith and sent to the District by 06/11/2023. **(Action by SDMs, BDOs)**
10. It is requested to the District Level Officers of Line Department to distribute same number and kind of benefits to the beneficiaries during camps of "Proti Ghore Sushason 2.0". **(Action by Line Departments)**
11. It has been instructed to DEO to inaugurate E-Class and also distribution of tablets/bicycle/scholarship etc. among the students by concerned Pradhans / Public Representatives during "Proti Ghore Sushason 2.0" **(Action by DEO)**
