- c) Monitor progress of investment projects and ensure timely implementation.
- d) Support the implementation of State policies and incentive schemes related to investment promotion in IT and digital sectors.
- e) Provide after-care services, including grievance redressal and continuous engagement with existing investors for expansion and retention.
