Memorandum

In the wake of spread of COVID-19 infection and to prevent imminent danger it has become necessary to expand the number of quarantine facilities and consequent upon which it has been decided to utilize the following facilities of Tourism/YAS/Home/Forests Department as designated quarantine centres. Respective DM & Collectors are requested to take over the following accommodating infrastructure Departmental head of the districts. DM's are also requested to keep the below noted facilities in readiness for housing quarantined people and necessary catering and other arrangements to be put in place to make it a full-fledged quarantine centre with designated facility Nodal Officers from either SDM or BDO office. This is in exercise of power under section 2 of the Epidemic disease Act 1897 read with notification No.F.13(13-132)-DFWPM/IDSP/2020(sub-I) dated 13th March 2020. The below noted facilities to be taken over forthwith from respective district authority and until further order the following places should be used as a designated quarantine centre.
