Kunjaban, Agartala - 799006 by Hand/ Post/ Currier Service should be submitted so as to reach the office of the Police Accountability Commission, Tripura on or before 22/08/2023 upto 2.00 pm. The sealed quotations will be opened on 22/08/2023 at 04.00pm, if possible in presence of the quotationer, if any. No quotation will be entertained if it does not reach this office within the stipulated date and time.

The quotation shall be submitted as per enclosed format Annexure-I.

Terms and condition are given below: -

- 1. The vehicle should preferably be white in colour and should be in good running condition. The vehicle should not be manufactured before the year 2022 also and should carry valid commercial license issued by the Transport Department, Government of Tripura, and possess all valid documents/ evidences as per Motor Vehicle Act. The copies of such supporting documents/ evidence must be attached with the sealed quotation.
- 2. The hiring charges of vehicles shall be guided by DFPRT-2019, Finance Deptt., Govt. of Tripura. The quoted rate by the bidders should not exceed the rate prescribed by the Finance Deptt. (Copy enclosed).

- 3. The vehicle should be placed 24(twenty four) hours X 23 (twenty three) working days in a month as per Delegation of Financial Power Rules, 2019. However on holidays if the vehicle is required for official purpose, payment will be made as per approved rate for the day(s).
- 4. Providing fuel, lubricants, dusters, maintenance of the car will have responsibility of the owners/proprietors/agencies of the vehicle.
- 5. Minimum basic accessories for the car will have to be provided by the owners/proprietors/agencies.
- 6. Running kilometer reading meter should be fitted with the vehicle in a running condition.
- 7. A driver should be placed with the car with valid driving licence and all expenditure of the driver should be borne by the owners/proprietors/agencies of the vehicle.
- 8. Any breakdown, accident, defects etc. will have to be attended immediately and to be repaired by the owner/ proprietor of the vehicle at his own cost and risk. A similar vehicle shall have to be placed by the owner/ proprietor as replacement during the period of repairing, if any, to avoid any difficulties towards smooth functioning of works of PAC.
- 9. Payment of hiring charges will be on monthly basis against submission of bill with logbook.
- 10. Applicable taxes shall be deducted from the monthly bill.
- 11. Log book in prescribed format is to be maintained for the daily journey and obtain signature of user.

- 12. Rate should be quoted both in digit and words including of all applicable taxes.
- 13. An earnest money amounting to Rs.5000/- (Rupees five thousand) only per vehicle in the form of D/call, in favour of "Secretary, Police Accountability Commission, Tripura" payable at Agartala shall be submitted alongwith sealed quotation. The said earnest money may be converted to security money for lowest successful bidder who would be offered the work. The rest earnest money of the others bidder would be refunded. The earnest money shall be forfeited in case of breaching of terms & condition within the period of hiring of the vehicle.
- 14. The hiring of vehicle shall be initially for one year at present which may be extended for further period on being satisfaction of service.
- 15. The Quotationer shall submit the following evidence/documents alongwith quotation without those no quotation shall be entertained.

- ii. GST registration certificate

- 16. The vehicle shall be parked on at night in the Garage of Police Accountability Commission, Tripura, if not otherwise negotiated.
- 17. Rate should be quoted within the ceiling fixed by Govt. of Tripura for hiring of vehicle.
- 18. Normally the vehicle will run in West Tripura District. But in case of necessity, the vehicle may have to run at any part of the State of Tripura for which no additional charges will be paid.
