NOTICE INVITING SPOT QUOTATION

On behalf of Teliamura Municipal Council (an ULB under Teliamura Sub Division of Khowai District, Tripura), Spot Quotation in plain paper is invited from the eligible/experienced Agencies/NGOs for Assessment of Solid Waste Generation and other assessments under the geographical area of Teliamura Municipal Council. The quotation will be received upto 25th August, 2024 (3 PM).

The Job will be as follows:

- (i) Assessment of Solid Waste Generation under the geographical area of Teliamura Municipal Council (TMC) as on date (Daily & Yearly basis)
- (ii) Assessment of processing capacity of the Teliamura Municipal Council for both wet & dry waste, to be calculated based on conditions/factors set by ULB.
- (iii) Assessment of required processing capacity of Teliamura Municipal Council for both wet & dry based on projected population of 2030 as per conditions set by the ULB.
- (iv) Preparation of Action Plan to be taken as immediate efforts, in case it is assessed that TMC do not have adequate processing capacity to process Solid Waste Generation targeted for year 2030.

The quotation should be submitted with the following documents: (a) Copy of Registration (b) Experience Certificate (c) PAN Card / TAN Card / GSTIN No. (d) up-to-date GST filing certificate and up-to-date IT Clearance Certificate (e) Trade License (f) Bank AC Details (g) Nationality Proof (Citizenship/PRTC/EPIC) of the intending bidder, not required in case of SHG/PACS/LAMPS/Co-operative Society Ltd/NGO etc.

TERMS & CONDITIONS:

1. The work shall be carried out as per the direction of the Nodal Officer, SBM, Teliamura MC and within the formula/conditions of the Urban Development Department/TMC in established scientific method.
2. The rate should be quoted both in words and figures with break-up, if any.
3. Time allowed for completion of the work is 25 (Twenty five) days.
4. Payment will be made after 100% completion of the work on satisfaction of the TMC.
5. Admissible Taxes will be deducted from the bill.
6. The complete set of blank quotation form to be purchased by intended bidders from the SBM Section, 1st Floor of Teliamura Municipal Council, Teliamura, Khowai District, Tripura, PIN

No. 799205 upto 20th August, 2024 (3 PM) on all Govt. working days only on payment of non-refundable fees of Rs. 500 (five Hundred) only. Any bidder may intend to purchase the quotation form without appearing the aforesaid address, may contact with Shri Bijuban Debbarma, Nodal Officer (Mobile: 7005583306 / 9862332727) to have the form through WhatsApp after producing payment proof to the Nodal Officer. 7. The bidder shall pay EMD in cash / DD of Rs. 10,000/- (Ten Thousand) in favour of the Deputy CEO, Teliamura Municipal Council to be submitted alongwith the bid. In case of L/1 bidder, the same amount shall be treated as Security Money, which will be released only after successful completion of the job.
8. Sealed Quotation must be submitted / reach to the office of the Teliamura Municipal Council, Teliamura, Khowai District, Tripura, PIN No. 799205 by 20th August, 2024 (3 PM). No postal delay etc will be entertained. Quotation will be opened on the next working day preferably at 11 AM if the said day not falls a holiday. Opening of quotation may be suitably deferred for any unforeseen reason.
9. Local experienced Agency / NGO with expertise on the matter may be given preference to carry out the job. Bidders who have experience certificate from CPHEEO (under MoHUA) may also be given priority.
10. In case rate quoted by two vendors is similar, then the eligible vendor will be decided through preferential condition as stated at 8 above or through lottery.
11. The quotation may be altered / cancelled at the discretion of the bid issuer and all disputes shall be under the jurisdiction of Courts in Khowai District, Tripura only.


