- 1. The quotation will be received only in the tender box of TTDC Ltd in sealed cover address to the Managing Director, Tripura Tea Development Corporation Ltd. Old Secretariat Complex, Agartala, Pin-799001 w.e.f. 28-06-2022 in normal office hours and up to 3.00 P/M on 06-07-2022 and shall be opened on 06-07-2022 at 4:00 P.M.
- 3. The tentative annual requirement of coal (ROM) 500 MT (Approx) of size ¹/₂" (Half inch) and above of Meghalaya. Out of which 100 MT for CTPF at Durgabari and 400 MT for BTPF at Brahmakunda, Simna, West Tripura, delivery at CTPF and BTPF.
- 4. The sealed quotation should accompany EMD for an amount of Rs.10,000/-(Rupees Ten thousand) only through Demand Draft to be drawn in favour of "Tripura Tea Development Corporation Ltd" and the sealed cover duly superscript as "RATE QUOTATION FOR SUPPLY OF COAL".
