1. Tender will be received w.e.f. **05-11-2021 to 20-11-2021** from 11 AM to 3.00 PM in the office of the **Tripura Tea Development Corporation Ltd. Old Secretariat Complex, Agartala, West Tripura, Pin-799001** and shall be opened on **20-11-2021 at 4.00 PM.**
2. Tender will also be entertained by post provided those must be reached on or **before 20-11-2021 upto 3.00 PM.**
3. Quoted rates should be inclusive of all taxes, duty, surcharge, fitting and fixing charge etc. Quotations should also be supported by the relevant valid documents of the Firm/Agency with experience certificate of previously executed the same nature of work done in Tea Factories.

The interested tenderer may visit to Central Tea Processing Factory (CTPF), Durgabari, Tebaria, West Tripura-799015 for inspection of the actual place and exact nature of conversion work, which to be done from existing Coal firing system to Natural Gas firing system for Tea Drying /withering of Green Leaves(4 Nos. Troughs) as per requirement with all items (Certified IPR Systems with Gas Filter of 300 SCUM/hr, DF heater shields, conventional burner, Seamless Pipes with fitting fixing with all necessary safety equipments/accessories)
