### TERMS & CONDITIONS


1. Tender will be received w.e.f. **06-09-2021 to 24-09-2021** from 11 AM to 3.00 PM in the office of the **Tripura Tea Development Corporation Ltd. Old Secretariat Complex, Agartala, West Tripura, Pin-799001** and shall be opened on **24-09-2021 at 4.00 PM.**
2. Tender will also be entertained by post provided those reach on or before **24/09/2021 upto 3.00 PM.**
3. Quoted rates should be inclusive of all taxes, duty, surcharge etc.
4. Tenders should be accompanied by **Earnest Money Deposit (EMD) of Rs.10,000 (Rupees ten thousand) only as "D Call/D Draft"** pledged in favour of **Tripura Tea Development Corporation Ltd. Agartala.**
5. The EMD of the successful tenderer shall be retained as Security Deposit, which will be considered for releasing full and complete supply, installation and commissioning with full satisfaction as per terms and conditions of this tender notice. EMD of the un-successful tenderers will be released within 3 (Three) days from the date of issue of supply order, if possible.
6. The successful Tenderer shall complete the supply, installation and commissioning as per order issued from this Corporation within 45 (forty five) days from the date of issue of this Order.
7. Payment will be made after successful completion of supply/installation/ commissioning fully electronic lorry weighbridge (pit mounted weighbridge with all accessories) with full satisfaction of the Authority and taxes and duties as per applicable shall be deducted from the bills unless authenticated documents for non-deduction are produced.

8. All disputes resulting from this tender notice and action thereon shall be under the jurisdiction at Agartala Court only.
9. Conditional tender(s) will not be entertained.
10. If the office remain closed on the Notified date of tender due to unforeseen reason or circumstance, the tender(s) may be dropped by the same time on the next working day. No further notice will be issued in this respect.
11. Any enhancement of rate within the validity period of contract will not be considered unless there is imposition of any levy or increase of existing levy by the Govt. otherwise such request will lead to cancellation of the order.
12. The tenderer should be submitted authenticated Copy of manufacturer's license issued by the concerned Legal metrology, authenticated copy of the model approval of weighbridge and company ISO Certification.
13. Annual Maintenance Contract (AMC) facilities shall have to be provided by the supplier.
14. The tenderer should submit their rate excluding civil foundation & other ancillary works of the weighbridge, on condition that the specification/design/drawing etc for the civil foundation work shall have to be provided by the selected vender after finalization of the tender.
15. The tender should invariably mention period of warranty, which shall be minimum 1 (one) year OEM warranty on all the spares/equipments installed by the Bidder if any of the installation does not cover under warranty of the OEM (civil & other ancillary works etc), it will be under sole responsibility of the bidder to repair replace the defective installation within the contract period.
16. The machine to be supplied, installed and commissioned within maximum 45 (forty five) days from the date of receipt of supply order by the successful manufacturer tenderer at their own cost and risk at the specified location as would be indicated in the supply order within the State of Tripura.
17. The bidder tenderer shall have to deposit an amount of Rs.10,000/- only as earnest money by means of deposit at call and to be pledged in favour of Managing Director, Tripura Tea Development Corporation Ltd., A Govt. of Tripura Undertaking, no tender shall be accepted without earnest money.
18. Payment (up to 80 %) will be made after satisfactory installation, commissioning functioning & successful trial run of the weighbridge and remaining 20% will be released after warranty period.
19. The Corporation reserves the right to reject or accept any tender or tenders including lowest one without assigning any reason or reasons in this ground.
