- 1. Tender for the year 2022-23 will be received in the office of the Tripura **Tea Development Corporation**, Old Secretariat Complex, AK Road, Agartala-799001 **up to** 3.00 pm w.e.f 07-02-2022 to 17-02-2022 and shall be opened at 4.00 PM on 17-02-2022, if possible.
- 2. Tender will be entertained by post provided those reach on or before 3.00 PM on 17-02-2022.
- 3. Tenderer should quote their rates in Rupees per 5, 10 & 20 Ltrs/kgs container/packet both in figure and words for delivery to concern garden of this Corporation at their own cost and risk.
- 4. Tenderer should submit GST Registration certificate along with Tender/quotation.
- 5. Tender should be accompanied by **Earnest Money Deposit** (EMD) of Rs.10,000/-(Rupees ten thousand) only as "**Deposit at Call or Demand Draft**" pledged in favour of **Tripura Tea Development Corporation Ltd, Agartala.**
- 6. The EMD of the successful tenderer will be retained as Security Deposit, which will be considered for release, subject to full and complete supply as per terms and conditions of this tender notice. - 10. The selection of type of PPCs/name of PPCs would be finalized as per our requirement.
- 11. The successful tenderer shall complete the entire supply as per order from this Corporation within 15 (Fifteen) days from the date of issue of this order.
- 12. Rate or rates quoted by the tenderers shall be final for the instant process of procurement. No sub-segment escalation of price will be accepted by the Corporation, even in case of increases of railway freight/ transportation cost/labour charges/ wages cost of stitching/handling charge etc.
- 13. Container/ bags found loose, torn, damage, wet etc. will not be accepted.
- 14. Payment will be made on the basis of actual quantity received in good condition and taxes and duties as applicable shall be deducted from the bills unless authenticated documents for non-deduction are produced.
