## **Notice Inviting Tender**

Sealed Tenders/Quotations in plain paper are hereby invited by the undersigned (Buyer) on behalf of this Corporation from reputed Supplier/Distributors/Dealers (seller) for supply of the Fertilizer to different Tea Estates (Kamalasagar TE, Brahmakunda TE, Machmara TE, Laxmilunga TE and Tufanilunga TE) under TTDC Ltd. for the year 2024-25. The details terms & conditions are given below:-

- 1. Tender will be received from 11.00 AM to 3.00 PM in all working days w.e.f. 11-03-2024 to 19-03-2024 in the tender box of the office of the Tripura Tea Development Corporation Ltd. Old Secretariat Complex, AK Road, Agartala-799001 and tender will be opened on 19-03-2024 at 4.00 PM, if possible.
- 2. Tender will be entertained by post provided those reach on or before 19-03-2024 upto 3.00 PM.
- 3. Tenderer should quote their rates in INR (Indian Rupee) per TON both in figure and words for delivery to 5 (five) Tea Estate at their own cost and risk.
- 4. Quoted rates should be inclusive of all taxes, duty, surcharge etc.
- 5. Tenders should be accompanied by **Earnest Money Deposit** (EMD) OF Rs.10,000/- (Rupees Ten thousand) only as "**Demand Draft**" pledged in favour of **Tripura Tea Development Corporation Ltd. Agartala** and the sealed cover duly superscript as "RATE QUOTATION FOR SUPPLY OF FERILIZER".
- 6. The EMD of the successful tenderer shall be retained as Security Deposit, which will be considered for releasing, subject to full and complete supply as per terms and conditions of this tender notice. EMD of the un-successful tenderers will be released within 7 (seven) days after completion of the tender process, if possible.
- 7. The materials should be supplied in 50 Kg. net in HPP Bags laminated with inside lining. The bags containing fertilizer should bear the name of the Manufacturer, Registration No., Brand Name, nutrient content in percentage etc. as per requirement of Fertilizer (Control) Order, 1985 and the Essential Commodities Act, 1955.
- 8. The rates will remain valid till completion of supply during the year 2024-25.
- 9. The successful Tenderer shall complete the entire supply as per order from this Corporation within 20 (Twenty) days from the date of issue of the supply order.
- 10. Rate or rates quoted by the tenderers shall be final for the instant process of procurement. No sub-segment escalation of price will be accepted by the Corporation, even in case of increases of rail way freight/ transportation cost/labour charge/ wages cost of stitching/ handing charge etc.
- 11. Bags found loose, torn, damage, wet etc. will not be accepted.
- 12. Payment will be made on the basis of actual quantity received in good condition and taxes and duties as per applicable shall be deducted from the bills unless authenticated documents for non-deduction are to be produced.

- 13. The supplier shall be liable to refund the cost of fertilizer for the quantity, which may be deducted as sub-standard by the Corporation.
- 14. The Corporation reserves the right to reject or accept any tender or tenders including lowest one without assigning any reason or reasons in this ground.
- 15. The quantity mentioned herein may be increased or decreased as discretion of the Corporation.
- 16. All disputes resulting from this tender notice and action thereon shall be under the jurisdiction at Agartala Court only.
- 17. Conditional tender(s) will not be entertained.
- 18. If, the office remain closed on the last date of the tender as notified due to unforeseen reason or circumstance, the tender(s) may be dropped by the same time on the next working day. No further notice will be issued in this respect.
- 19. Any enhancement of rate within the validity period of contract will not be considered unless there is imposition of any levy or increase of existing levy by the Govt. otherwise such request will lead to cancellation of the order.
