Notice Inviting Restricted Sealed Rate Quotations for for complete supply, installation and commissioning of 2nd line sorting system with synchronizing of existing sorting arrangement of CTC Tea in BTPF, Simna under North Eastern Council (NEC), Shillong funded project.

The undersigned on behalf of Tripura Tea Development Corporation Ltd. Agartala is here by invited sealed quotation from the Original Equipment Manufacturers (OEMs) as per following specifications as given below-

Complete supply/ installation/commissioning of 2^{nd} line sorting system with synchronizing existing of sorting arrangement of CTC Tea in BTPF, Simna with the following machineries etc for smooth sorting system in BTPF, Simna under TTDC Ltd..

- Vibro 6 nos. electrostatic rollers slow speed fiber extractor with all complete accessories and Multigrader cum cleaning machine having 36" in width jigger tray with overhead storage tank, 4 nos 12" in dia electrostatic rollers, complete with drive arrangement 2HP motor, starter, pulley, vee belt etc with Mesh tray nos. 40; 14; 18;20 & 24, fiber collecting drain & foundation bolts., 5 Nos. Wooden storage bin (Appx. 2000 kgs capacity each) to be placed on newly constructed mazine floor in BTPF, Simna with necessary arrangement of fixed / portable conveyor system for lifting the bulk tea and graded tea up to storage bins from existing ground floor of sorting room for the purpose of clean and evenly graded CTC Teas for annual capacity of approx. 6 Lakh kgs CTC Made Tea handling system.
- 1. The sealed quotation should accompany EMD @2.5% of the rate quotated through Demand Draft to be drawn in favour of "Tripura Tea Development Corporation Ltd."
- 2. Un-sealed quotation will not be entertained and would be rejected. The sealed quotation should subscribe "2nd line sorting system with synchronizing existing sorting arrangement of CTC Tea in BTPF, Simna".
- 3. Tender will be received w.e.f. 18-09-2025 2025 to 09-10-2025 from 11 AM to 3.00 PM in the office of the Tripura Tea Development Corporation Ltd. Old Secretariat Complex, Agartala, West Tripura, Pin-799001 and shall be opened 09-10-2025 at 4.00 PM, if possible.
- **4.** Tender will also be entertained by post provided those must be reached on or **before** 09-10-2025 upto 3.00 PM.
- **5.** Quoted rates should be inclusive of all taxes, duty, surcharge etc. and mentioning the Registered Brand and Manufacturer name under concerned Govt. Dept. of said machineries should clearly be written in the quotations.
- **6.** The interest tenderer may visit to Brahmakunda Tea Processing Factory (BTPF), Simna under TTDC Ltd before dropping tender for estimation physically for proper execution of the said work.



- The successful Tenderer shall deposit 5% as security money through D. Draft in favour of the Managing Director, TTDC Ltd. within 7 (Seven) days after confirmation from this end on the basis of the value of supply order as to be allotted particularly for the lowest rate offerer. The Security Money shall be released after 6 (six) months, subject to full and complete supply, installation and commissioning with full satisfaction as per terms and conditions of this tender notice.
- The work/assignment indicated above should be completed by successful tenderer within 90 days from the date of issuance supply order and for delay @ 0.05% per day penalty would be imposed and would be adjusted with the final payment.
- 9. Payment will be made after successful completion Installation/commission of the said system with full satisfaction of the Authority and taxes and duties as per applicable shall be deducted from the bills unless authenticated documents for non-deduction are to be produced as per norms of NEC, Shillong.
- 10. The participation tenderer should have previous experience of the executing of similar nature of work with proven records to be submitted along with tender.
- 11. All disputes resulting from this tender notice and action thereon shall be under the jurisdiction at Agartala Court only.
- 12. Conditional tender (s) will not be entertained.
- 13. If the office remains closed on the last date of the tender as notified due to unforeseen reason or circumstance, the tender (s) may be dropped by the same time on the next working day. No further notice will be issued in this respect.
