NOTICE INVITING TENDER

Notice Inviting Tender in sealed cover is hereby invited from the interested authorized Transporter/Carrier for Carrying of Made tea from the Central Tea Processing factory, Durgabari, and Brahmakunda Tea Processing Factory, Brahmakunda, Simna, West Tripura under TTDC Ltd. to Warehouse at Taratala Road, Kolkata for the for the year 2022-23 as per following Terms & Conditions:-

- 1. The quotation will be received only in the tender box of TTDC Ltd in sealed cover address to the Managing Director, **Tripura Tea Development Corporation Ltd. Old Secretariat Complex, Agartala, Pin-799001** w.e.f. 17-05-2022 in normal office hours and up to 3.00 P.M on 27-05-2022 and the tender box will be opened on 27-05-2022 at 4:00 P.M if possible.
- 2. Rate should be quoted both in figures and words in INR.
- 3. Flat rates in plain paper per kg from CTPF, Durgabari & BTPF, Simna should be quoted inclusive of all costs of carriage, loading / unloading charges etc.
- 4. Earnest money of Rs.10,000/- (Rupees ten thousand) only in the form of Demand Draft, in favour of MD,TTDC Ltd. should be submitted along with the tender and the same will be converted subsequently in to Security deposit in case of successful tenderer.
- 5. The Transporter shall place required number of vehicles in good condition within specified date on receipt of requisition. If the transporter fails to place the vehicles within schedule date & time, this Corporation have the right to get its goods transported through other transporter and if any extra cost is involved in such event the same shall have to be made by the transporter.
- 6. In the event failure of the transporter to place required number of vehicles on 3 (three) occasions during the period of contract, the Corporation shall have the right to cancel the contract and shall forfeit the Security deposit of the transporter without assigning any reason.
- 7. The articles would be handed over to the transporter from the Factory of the Corporation with proper Invoice and way bill
- 8. For carriage of articles only full Truck of 15(Fifteen)/ 10(ten) ton capacity should be placed.

- 9. Articles will be dispatched by the Corporation on full truck basis for transportation. The Transporter shall be debarred to carry articles of other party in the same truck as part load or any transshipment on the way. If any deviation is detected, the Corporation shall have the right to cancel the contract.
- 10. Carriage of made tea from CTPF (Durgabari)/ BTPF (Simna, Mohanpur) to Kolkata Ware House at Taratala Road.) need to be completed within 7 (seven) days time from the date of received of the particular consignment. For delay beyond the said period an amount of Rs.1000/- (Rupees one thousand) only per day will be deducted from the bill of the Transporter as business loss. For delay due to road blockade/flood/ earth quake/agitations/ the transporter need to submit details justifications, which may be considered by the Corporation its discretion.
- 11. The Corporation will not be responsible for any delay en-route due to break down of the vehicle and other reason not attributable to the Corporation.
- 12. The Transporter shall be solely responsible for delivery of stock as may be mentioned in the consignment note in good condition to the consignee with proper e-way bill. In case of any shortage/loss/damage of any Tea bags during transit or at the time of delivery, the entire value of such shortage/loss/damage articles will be recovered from the transporter and on recovery of the value of damaged items.
- 13. If the Tenderer, surrender his rate before finalization of the tender. In such case the earnest money deposited with the tender will be liable to be forfeited by the Corporation.
- 14. Rate once accepted will remain valid for the entire period of contract i.e FY 2020-23 and no review or escalation would be entertained under any circumstances.
- 15. The sealed cover super scribed on the top of the envelope "Tender for Transportation Contract" should be addressed to the Managing Director, Tripura Tea Development Corporation Ltd'. Old Secretariat Complex, Po. Agartala, Pin 799001, Tripura (W).
- 16. The transporter shall have to submit original Consignee copy with receipt of ware house with bill for making payment from this end.
- 17. As per govt. norms from each bill of the transporter will be made as Income tax/ GST plus admissible surcharge or such tax may be deducted.
- 18. Any litigation related with the contact shall be the Jurisdiction of Agartala Court only.
- 19. The under signed reserved the right to accept/reject any or all tenders either wholly or partly without assigning any reasons.
- 20. If the office remain closed on the last date of the tender as notified due to unforeseen reason or circumstance, the tender(s) may be dropped by the same time on the next working day. No further notice will be issued in this respect.
