Animal Resources Development Department (ARDD), Government of Tripura is emphasizing on increasing production and productivity of Pig in the State through distribution of exotic / improved crossbred piglets (LWY / LR / HAMPSHIRE / CROSBRED within the breeds) to the farmers under different beneficiary oriented schemes for livelihood generation. Approximate number of piglet requirement is 5000 no. per year (variable), with male and female ratio 1:4 respectively.

In view of the above, ARDD invites Expression of Interest (EoI) from bona-fide Pig breeding farms (Govt. / Private) / Companies / Agencies (henceforth mentioned as SUPPLIER) for

- 1. Supply of exotic / improved crossbred piglets of 2(two) to 3 (three) months age with minimum body weight of 18 kg.
- **2.** Piglets should be vaccinated against Classical Swine Fever (CSF) and Foot and Mouth Disease (FMD) duly certified by Registered Veterinary Practitioner (mentioning Regn. No.) should be free from any disease condition and anatomical deformities.
- **3.** Piglets should be Originating from an area free from African Swine Fever (ASF) disease. Necessary certification from Registered Veterinary Practitioner must accompany the consignment.
- **4.** Delivery of piglets from suppliers will be at the point of each District HQ in the state of Tripura by the supplier.

This document contains instructions on the preparation and submission of the Application including Annexure-A: Supplier's information.

- 1. Interested Supplier may submit the EXPRESSION OF INTEREST on or before **4.00 PM** of **1**st day of **May' 2021** addressed to the Director, Animal Resources Development Department, Government of Tripura, P. N. Complex, Agartala- 799006, in Sealed Cover Envelop labeled as "Expression of Interest for Empanelment of Piglet Supplier" mentioning File Number, Issuing Date and Last Date of submission through Speed Post / Courier Service / Registered Post.
- 2. Documents should be submitted with Self Certification by giving full signature of authorized concern with seal.
- 3. Name and Complete address of the Supplier with Phone, Fax, e-mail address along with valid requisite registration certificate (attach Copy).
- 4. Detailed description must be provided on how the requirements specified in this document match the capability, experience, knowledge and expertise of the Supplier.
- 5. Application must be submitted in English Language and in the Format prescribed by ARDD. All required information must be provided, responding clearly on all the points set out. Any application which does not address the Request for Expression in full and precisely may be rejected.

- 6. The application document shall comprise the following:
 - i. Cover Letter
 - ii. A copy of the Request for Expression of Interest duly signed on all pages by the Company / Farm / Suppliers Authorized Signatory with seal: and
 - iii. Duly filled **Annexure-A** with all requested information and supportive documents required as mentioned against each.
- 7. Applications shall be evaluated in accordance with the following criteria;
 - (a) Supplier should be registered in India for at least 2 years with adequate infrastructure (detailed description with Breeding stock and Piglet production capacity is mandatory) in Operational condition attach supportive documents.
 - (b) Must have capability of supplying minimum 3000 (three thousand) no. of Piglets per year.
 - (c) Must be capable of supplying minimum 500 (five hundred) to 1000 (one thousand) no. of Piglets per consignment within 90 days supply notice / order from this end.
 - (d) Experience in providing such services including transportation for any states in India, directly or in collaboration with other agencies.
- 8. Applications may be modified or withdrawn in writing, prior to the closing time specified in this Request for EoI.
- 9. All information given in writing to or verbally shared with the Supplier in connection with this Request for EoI is to be treated as strictly confidential. The Supplier shall not share or invoke such information to any third party without the prior written approval of ARDD. This obligation shall continue till the process has been completed and whether or not the Supplier is successful.
- 10. The documents for Expression of Interest after receipt from the Supplier will be scrutinized and short listed in accordance with the terms and conditions as indicated above by the Departmental Technical Committee (DTC).
- 11. ARDD reserves the right to accept or reject any Application, and to cancel the process and reject all Applications, at any time without assigning any reason and thereby incurring any liability to the affected Supplier or any obligation to inform the affected Supplier on the ground for ARDD's action. The decision of the Government in this regard would be final and binding. No further query shall be entertained in this aspect.
- 12. In case of legal dispute, the jurisdiction will be the High Court of Tripura, Agartala.
