

2. The Electoral Rolls for the Village Committee Constituencies shall be based on the Electoral Rolls of the State Assembly Constituencies for the time being in force.

3. All the Electoral Registration Officers should follow the relevant provisions of the 'Tripura Tribal Areas Autonomous District Village Committee (Preparation of Electoral Roll) Rules, 1996 for draft and final publication of the Electoral Rolls.


