**NOTIFICATION**

Subject:- Teachers' Recruitment Board for conducting **Teacher Eligibility Test (TET) in Tripura State.**

There is a need to put a transparent process in place for selection of candidates to make appointment at different levels of School Education i.e. Elementary Stage (I-VIII), Secondary Stage (IX-X) and Higher Secondary Stage (XI-XII). Consequently, a suitable professional body is considered to be designated. It has accordingly been decided that a Teachers' Recruitment Board shall be constituted as follows:-

1. Chairman.
2. Three members.
3. Member Secretary.

2. The Chairman and the Members shall hold office for a term of five years, if not otherwise disqualified. The term of office may be extended for a further period of five years until attaining the age of 70 years. The Member-Secretary shall function as Ex-Officio. The posts of Controller of Examinations, Accounts Officer and other ministerial staff shall be filled up by deputation from the School Education & other Departments. The honorarium of the Chairman and other members shall be fixed by the State Government.

3. The Board shall exercise powers throughout the State of Tripura and its headquarters shall be established in the premises of State Council of Educational Research and Training (SCERT), Agartala. Other functional and administrative norms will be framed from time to time by the School Education Department in consultation with the Teachers' Recruitment Board as per the guidelines of National Council for Teacher Education (NCTE).

The functions of the Teachers' Recruitment Board shall be as follows:-


- i. Preparation of guidelines on the matter relating to the methods of selection of teachers as per requirement.
- ii. Inviting applications by means of advertisement and scrutinizing applications received on line/by post in response to the advertisement.
- iii. Selection of Examination centers/venues and conduct of Teacher Eligibility Test (TET) for Elementary Teachers (I-VIII) as per the guidelines of NCTE and conduct of written test for Graduate Teachers (IX-X) and Post Graduate Teachers (XI-XII).
- iv. Selection of candidates and recommendation of names of selected candidates to the concerned authorities for appointment as Under Graduate Teachers, Graduate Teachers and Post Graduate Teachers to the Government/Govt. aided and other schools in the State as per requirement from the School Education Department / Govt. Aided Schools/ SSA Rajya Mission/RMSA/TTAADC & other authorities.
- v. Fixation of Examination fees, emoluments, Travelling and other allowances of the experts and examiners.

- vi. Maintaining records of the selection made by the Board by computerization and networking of recruitment activities to ensure transparency and accuracy.
- vii. Administering the fund placed at the disposal of the Teachers' Recruitment Board.
- viii. Performing such other duties and exercise such other powers as may be prescribed.

4. This is issued as per the decision of the Council of Ministers conveyed, vide Memorandum No.F.1(9)-GA(CAB)/2000/(Vol-II) dated 31-12-2014 of the Government of Tripura in the General Administration (Confidential & Cabinet) Department.


